1 elementary school may not be assigned for two consecutive school years to a teacher teaching a subject in the foundation curriculum 2 under Section 28.002(a)(1) who has less than one year of teaching 3 experience and who does not hold the appropriate certificate 4 5 required under Section 21.003 unless: 6 (1) the student's parent or other person standing in 7 parental relation to the student and a school counselor or school administrator agree otherwise regarding assignment of the student 8 to the teacher; or 9 (2) the assignment of the student to the teacher 10 occurs during the first year a student transfers into a school 11 12 district. (c) The commissioner may grant a waiver from 13 the 14 requirements of this section to a school district if the 15 commissioner finds that extreme circumstances in the district warrant the waiver. The commissioner may adopt rules as necessary 16 17 to implement this section. SECTION 3. This Act applies beginning with the 2025-2026 18 19 school year. SECTION 4. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 23 Act does not receive the vote necessary for immediate effect, this 24 Act takes effect September 1, 2025.
