7	SECTION 1. Subtitle C, Title 4, Special District Local Laws		
8	Code, is amended by adding Chapter 4012 to read as follows:		
9	CHAPTER 4012. LA CIMA MUNICIPAL MANAGEMENT DISTRICT NO. 1		
10	SUBCHAPTER A. GENERAL PROVISIONS		
11	Sec. 4012.0101. DEFINITIONS. In this chapter:		
12	(1) "Board" means the district's board of directors.		
13	(2) "City" means the City of San Marcos.		
14	(3) "Director" means a board member.		
15	(4) "District" means La Cima Municipal Management		
16	District No. 1.		
17	Sec. 4012.0102. NATURE OF DISTRICT. La Cima Municipal		
18	Management District No. 1 is a special district created under		
19	Section 59, Article XVI, Texas Constitution.		
20	Sec. 4012.0103. PURPOSE; DECLARATION OF INTENT. (a) The		
21	creation of the district is essential to accomplish the purposes of		
22	Sections 52 and 52-a, Article III, and Section 59, Article XVI,		
23	Texas Constitution, and other public purposes stated in this		
24	chapter.		

- 1 (b) By creating the district and in authorizing the city and
- 2 other political subdivisions to contract with the district, the
- 3 legislature has established a program to accomplish the public
- 4 purposes set out in Section 52-a, Article III, Texas Constitution.
- 5 (c) The creation of the district is necessary to promote,
- 6 develop, encourage, and maintain employment, commerce,
- 7 transportation, housing, tourism, recreation, the arts,
- 8 entertainment, economic development, safety, and the public
- 9 welfare in the district.
- 10 (d) This chapter and the creation of the district may not be
- 11 interpreted to relieve the city from providing the level of
- 12 services provided as of the effective date of the Act enacting this
- 13 chapter to the area in the district. The district is created to
- 14 supplement and not to supplant city services provided in the
- 15 district.
- Sec. 4012.0104. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 17 (a) All land and other property included in the district will
- 18 benefit from the improvements and services to be provided by the
- 19 district under powers conferred by Sections 52 and 52-a, Article
- 20 III, and Section 59, Article XVI, Texas Constitution, and other
- 21 powers granted under this chapter.
- 22 (b) The district is created to serve a public use and
- 23 benefit.
- (c) The creation of the district is in the public interest
- 25 and is essential to further the public purposes of:
- 26 (1) developing and diversifying the economy of the
- 27 state;

- 1 (2) eliminating unemployment and underemployment; and
- 2 (3) developing or expanding transportation and
- 3 commerce.
- 4 (d) The district will:
- 5 (1) promote the health, safety, and general welfare of
- 6 residents, employers, potential employees, employees, visitors,
- 7 and consumers in the district, and of the public;
- 8 (2) provide needed funding for the district to
- 9 preserve, maintain, and enhance the economic health and vitality of
- 10 the district territory as a community and business center;
- 11 (3) promote the health, safety, welfare, and enjoyment
- 12 of the public by providing pedestrian ways and by landscaping and
- 13 developing certain areas in the district, which are necessary for
- 14 the restoration, preservation, and enhancement of scenic beauty;
- 15 and
- 16 (4) provide for water, wastewater, drainage, road, and
- 17 <u>recreational facilities for the district.</u>
- 18 (e) Pedestrian ways along or across a street, whether at
- 19 grade or above or below the surface, and street lighting, street
- 20 landscaping, parking, and street art objects are parts of and
- 21 necessary components of a street and are considered to be a street
- 22 <u>or road improvement.</u>
- 23 (f) The district will not act as the agent or
- 24 instrumentality of any private interest even though the district
- 25 will benefit many private interests as well as the public.
- Sec. 4012.0105. INITIAL DISTRICT TERRITORY. (a) The
- 27 district is initially composed of the territory described by

- 1 Section 2 of the Act enacting this chapter.
- 2 (b) The boundaries and field notes contained in Section 2 of
- 3 the Act enacting this chapter form a closure. A mistake in the
- 4 field notes or in copying the field notes in the legislative process
- 5 does not affect the district's:
- 6 (1) organization, existence, or validity;
- 7 (2) right to issue any type of bonds for the purposes
- 8 for which the district is created or to pay the principal of and
- 9 interest on the bonds;
- 10 (3) right to impose or collect an assessment or tax; or
- 11 (4) legality or operation.
- 12 Sec. 4012.0106. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 13 All or any part of the area of the district is eligible to be
- 14 <u>includ</u>ed in:
- 15 (1) a tax increment reinvestment zone created under
- 16 Chapter 311, Tax Code; or
- 17 (2) a tax abatement reinvestment zone created under
- 18 Chapter 312, Tax Code.
- 19 Sec. 4012.0107. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 20 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 21 Chapter 375, Local Government Code, applies to the district.
- Sec. 4012.0108. CONSTRUCTION OF CHAPTER. This chapter
- 23 shall be liberally construed in conformity with the findings and
- 24 purposes stated in this chapter.
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 4012.0201. GOVERNING BODY; TERMS. (a) The district is
- 27 governed by a board of five elected directors who serve staggered

- 1 terms of four years.
- 2 (b) Directors are elected in the manner provided by
- 3 Subchapter D, Chapter 49, Water Code.
- 4 Sec. 4012.0202. COMPENSATION; EXPENSES. A director is
- 5 entitled to receive fees of office and reimbursement for actual
- 6 expenses as provided by Section 49.060, Water Code. Sections
- 7 375.069 and 375.070, Local Government Code, do not apply to the
- 8 board.
- 9 Sec. 4012.0203. INITIAL DIRECTORS. (a) The initial board
- 10 consists of the following directors:

- SUBCHAPTER C. POWERS AND DUTIES
- Sec. 4012.0301. GENERAL POWERS AND DUTIES. The district
- 23 has the powers and duties necessary to accomplish the purposes for
- 24 which the district is created.
- Sec. 4012.0302. IMPROVEMENT PROJECTS AND SERVICES. (a) The
- 26 district, using any money available to the district for the
- 27 purpose, may provide, design, construct, acquire, improve,

- 1 relocate, operate, maintain, or finance an improvement project or
- 2 service authorized under this chapter or Chapter 375, Local
- 3 Government Code.
- 4 (b) The district may contract with a governmental or private
- 5 entity to carry out an action under Subsection (a).
- 6 (c) The implementation of a district project or service is a
- 7 governmental function or service for the purposes of Chapter 791,
- 8 Government Code.
- 9 Sec. 4012.0303. NONPROFIT CORPORATION. (a) The board by
- 10 resolution may authorize the creation of a nonprofit corporation to
- 11 assist and act for the district in implementing a project or
- 12 providing a service authorized by this chapter.
- 13 (b) The nonprofit corporation:
- 14 (1) has each power of and is considered to be a local
- 15 government corporation created under Subchapter D, Chapter 431,
- 16 Transportation Code; and
- 17 (2) may implement any project and provide any service
- 18 authorized by this chapter.
- 19 (c) The board shall appoint the board of directors of the
- 20 nonprofit corporation. The board of directors of the nonprofit
- 21 corporation shall serve in the same manner as the board of directors
- 22 of a local government corporation created under Subchapter D,
- 23 Chapter 431, Transportation Code, except that a board member is not
- 24 required to reside in the district.
- Sec. 4012.0304. LAW ENFORCEMENT SERVICES. To protect the
- 26 public interest, the district may contract with a qualified party,
- 27 including the city, to provide law enforcement services in the

- 1 district for a fee.
- 2 Sec. 4012.0305. MEMBERSHIP IN CHARITABLE ORGANIZATIONS.
- 3 The district may join and pay dues to a charitable or nonprofit
- 4 organization that performs a service or provides an activity
- 5 consistent with the furtherance of a district purpose.
- 6 Sec. 4012.0306. ECONOMIC DEVELOPMENT PROGRAMS. (a) The
- 7 district may engage in activities that accomplish the economic
- 8 development purposes of the district.
- 9 (b) The district may establish and provide for the
- 10 administration of one or more programs to promote state or local
- 11 economic development and to stimulate business and commercial
- 12 activity in the district, including programs to:
- 13 (1) make loans and grants of public money; and
- 14 (2) provide district personnel and services.
- 15 (c) The district may create economic development programs
- 16 and exercise the economic development powers provided to
- 17 municipalities by:
- 18 (1) Chapter 380, Local Government Code; and
- 19 (2) Subchapter A, Chapter 1509, Government Code.
- Sec. 4012.0307. PARKING FACILITIES. (a) The district may
- 21 acquire, lease as lessor or lessee, construct, develop, own,
- 22 operate, and maintain parking facilities or a system of parking
- 23 facilities, including lots, garages, parking terminals, or other
- 24 structures or accommodations for parking motor vehicles off the
- 25 streets and related appurtenances.
- 26 (b) The district's parking facilities serve the public
- 27 purposes of the district and are owned, used, and held for a public

- 1 purpose even if leased or operated by a private entity for a term of
- 2 <u>years.</u>
- 3 (c) The district's parking facilities are parts of and
- 4 necessary components of a street and are considered to be a street
- 5 or road improvement.
- 6 (d) The development and operation of the district's parking
- 7 facilities may be considered an economic development program.
- 8 Sec. 4012.0308. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 9 board by resolution shall establish the number of directors'
- 10 signatures and the procedure required for a disbursement or
- 11 transfer of district money.
- 12 Sec. 4012.0309. ADDING OR EXCLUDING LAND. Except as
- 13 provided by Section 4012.0310, the district may add or exclude land
- 14 in the manner provided by Subchapter J, Chapter 49, Water Code, or
- 15 by Subchapter H, Chapter 54, Water Code.
- Sec. 4012.0310. DIVISION OF DISTRICT. (a) The district may
- 17 <u>be divided into two or more new districts only if the district:</u>
- 18 (1) has no outstanding bonded debt; and
- 19 (2) is not imposing ad valorem taxes.
- 20 (b) This chapter applies to any new district created by the
- 21 division of the district, and a new district has all the powers and
- 22 <u>duties of the district.</u>
- 23 (c) Any new district created by the division of the district
- 24 may not, at the time the new district is created, contain any land
- 25 outside the area described by Section 2 of the Act enacting this
- 26 chapter.
- 27 (d) The board, on its own motion or on receipt of a petition

- 1 signed by the owner or owners of a majority of the assessed value of
- 2 the real property in the district, may adopt an order dividing the
- 3 district.
- 4 (e) An order dividing the district must:
- 5 (1) name each new district;
- 6 (2) include the metes and bounds description of the
- 7 territory of each new district;
- 8 (3) appoint initial directors for each new district;
- 9 and
- 10 (4) provide for the division of assets and liabilities
- 11 between or among the new districts.
- (f) On or before the 30th day after the date of adoption of
- 13 an order dividing the district, the district shall file the order
- 14 with the Texas Commission on Environmental Quality and record the
- 15 order in the real property records of each county in which the
- 16 district is located.
- 17 (g) Municipal consent to the creation of the district and to
- 18 the inclusion of land in the district granted under Section
- 19 4012.0506 acts as municipal consent to the creation of any new
- 20 district created by the division of the district and to the
- 21 inclusion of land in the new district.
- Sec. 4012.0311. EMINENT DOMAIN. The district may exercise
- 23 the power of eminent domain in the manner provided by Section
- 24 49.222, Water Code.
- SUBCHAPTER D. ASSESSMENTS
- Sec. 4012.0401. PETITION REQUIRED FOR FINANCING SERVICES
- 27 AND IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a

- 1 service or improvement project with assessments under this chapter
- 2 unless a written petition requesting that service or improvement
- 3 has been filed with the board.
- 4 (b) A petition filed under Subsection (a) must be signed by
- 5 the owners of a majority of the assessed value of real property in
- 6 the district subject to assessment according to the most recent
- 7 certified tax appraisal roll for the county.
- 8 Sec. 4012.0402. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 9 The board by resolution may impose and collect an assessment for any
- 10 purpose authorized by this chapter in all or any part of the
- 11 <u>district.</u>
- 12 (b) An assessment, a reassessment, or an assessment
- 13 resulting from an addition to or correction of the assessment roll
- 14 by the district, penalties and interest on an assessment or
- 15 reassessment, an expense of collection, and reasonable attorney's
- 16 <u>fees incurred by the district:</u>
- 17 (1) are a first and prior lien against the property
- 18 assessed;
- 19 (2) are superior to any other lien or claim other than
- 20 a lien or claim for county, school district, or municipal ad valorem
- 21 taxes; and
- 22 (3) are the personal liability of and a charge against
- 23 the owners of the property even if the owners are not named in the
- 24 <u>assessment proceedings.</u>
- 25 (c) The lien is effective from the date of the board's
- 26 resolution imposing the assessment until the date the assessment is
- 27 paid. The board may enforce the lien in the same manner that the

- 1 board may enforce an ad valorem tax lien against real property.
- 2 (d) The board may make a correction to or deletion from the
- 3 assessment roll that does not increase the amount of assessment of
- 4 any parcel of land without providing notice and holding a hearing in
- 5 the manner required for additional assessments.
- 6 SUBCHAPTER E. TAXES AND BONDS
- 7 Sec. 4012.0501. TAX ELECTION REQUIRED. (a) The district
- 8 must hold an election in the manner provided by Chapter 49, Water
- 9 Code, or, if applicable, Chapter 375, Local Government Code, to
- 10 obtain voter approval before the district may impose an ad valorem
- 11 <u>tax.</u>
- 12 (b) Section 375.243, Local Government Code, does not apply
- 13 to the district.
- 14 Sec. 4012.0502. OPERATION AND MAINTENANCE TAX. (a) If
- 15 authorized by a majority of the district voters voting at an
- 16 election under Section 4012.0501, the district may impose an
- 17 operation and maintenance tax on taxable property in the district
- 18 in the manner provided by Section 49.107, Water Code, for any
- 19 district purpose, including to:
- 20 (1) maintain and operate the district;
- 21 (2) construct or acquire improvements; or
- 22 <u>(3) provide a service.</u>
- (b) The board shall determine the operation and maintenance
- 24 tax rate. The rate may not exceed the rate approved at the
- 25 election.
- Sec. 4012.0503. AUTHORITY TO BORROW MONEY AND TO ISSUE
- 27 BONDS AND OTHER OBLIGATIONS. (a) The district may borrow money on

- 1 terms determined by the board.
- 2 (b) The district may issue, by public or private sale,
- 3 bonds, notes, or other obligations payable wholly or partly from ad
- 4 <u>valorem taxes, assessments, impact fees, revenue, contract</u>
- 5 payments, grants, or other district money, or any combination of
- 6 those sources of money, to pay for any authorized district purpose.
- 7 (c) The district may issue, by public or private sale,
- 8 bonds, notes, or other obligations payable wholly or partly from
- 9 assessments in the manner provided by Subchapter A, Chapter 372,
- 10 Local Government Code, if the improvements financed by an
- 11 obligation issued under this section will be conveyed to or
- 12 operated and maintained by a municipality or other retail utility
- 13 provider pursuant to an agreement with the district entered into
- 14 before the issuance of the obligation.
- 15 Sec. 4012.0504. BONDS SECURED BY REVENUE OR CONTRACT
- 16 PAYMENTS. The district may issue, without an election, bonds
- 17 secured by:
- 18 (1) revenue other than ad valorem taxes, including
- 19 contract revenues; or
- 20 (2) contract payments, provided that the requirements
- 21 of Section 49.108, Water Code, have been met.
- Sec. 4012.0505. BONDS SECURED BY AD VALOREM TAXES;
- 23 ELECTIONS. (a) If authorized at an election under Section
- 24 4012.0501, the district may issue bonds payable from ad valorem
- 25 taxes.
- 26 (b) At the time the district issues bonds payable wholly or
- 27 partly from ad valorem taxes, the board shall provide for the annual

- 1 imposition of a continuing direct annual ad valorem tax, without
- 2 limit as to rate or amount, for each year that all or part of the
- 3 bonds are outstanding as required and in the manner provided by
- 4 Sections 54.601 and 54.602, Water Code.
- 5 (c) All or any part of any facilities or improvements that
- 6 may be acquired by a district by the issuance of its bonds may be
- 7 submitted as a single proposition or as several propositions to be
- 8 voted on at the election.
- 9 Sec. 4012.0506. CONSENT OF MUNICIPALITY REQUIRED. (a) The
- 10 board may not issue bonds until each municipality in whose
- 11 corporate limits or extraterritorial jurisdiction the district is
- 12 located has consented by ordinance or resolution to the creation of
- 13 the district and to the inclusion of land in the district as
- 14 required by applicable law.
- 15 (b) This section applies only to the district's first
- 16 <u>issuance of bonds payable from ad valorem taxes.</u>
- 17 <u>SUBCHAPTER I. DISSOLUTION</u>
- Sec. 4012.0901. DISSOLUTION. (a) The board shall dissolve
- 19 the district on written petition filed with the board by the owners
- 20 of:
- 21 (1) at least two-thirds of the assessed value of the
- 22 property subject to assessment by the district based on the most
- 23 recent certified county property tax rolls; or
- 24 (2) at least two-thirds of the surface area of the
- 25 district, excluding roads, streets, highways, utility
- 26 rights-of-way, other public areas, and other property exempt from
- 27 assessment by the district according to the most recent certified

- 1 county property tax rolls.
- 2 (b) The board by majority vote may dissolve the district at
- 3 any time.
- 4 (c) The district may not be dissolved by its board under
- 5 Subsection (a) or (b) if the district:
- 6 (1) has any outstanding bonded indebtedness until that
- 7 bonded indebtedness has been repaid or defeased in accordance with
- 8 the order or resolution authorizing the issuance of the bonds;
- 9 <u>(2) has a contractual obligation to pay money until</u>
- 10 that obligation has been fully paid in accordance with the
- 11 contract; or
- 12 (3) owns, operates, or maintains public works,
- 13 facilities, or improvements unless the district contracts with
- 14 another person for the ownership, operation, or maintenance of the
- 15 public works, facilities, or improvements.
- 16 (d) Sections 375.261, 375.262, and 375.264, Local
- 17 Government Code, do not apply to the district.
- 18 SECTION 2. La Cima Municipal Management District No. 1
