A BILL TO BE ENTITLED AN ACT

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Sec. 4012.0303. NONPROFIT CORPORATION. (a) The board by resolution may authorize the creation of a nonprofit corporation to assist and act for the district in implementing a project or providing a service authorized by this chapter.

The nonprofit corporation:
(1) has each power of and is considered to be a local government corporation created under Subchapter D, Chapter 431, Transportation Code; and

(2) may implement any project and provide any service

authorized by this chapter.

(c) The board shall appoint the board of directors of the nonprofit corporation. The board of directors of the nonprofit corporation shall serve in the same manner as the board of directors of a local government corporation created under Subchapter D, Chapter 431, Transportation Code, except that a board member is not required to reside in the district.

Sec. 4012.0304. LAW ENFORCEMENT SERVICES. To protect the

public interest, the district may contract with a qualified party, including the city, to provide law enforcement services in the district for a fee.

Sec. 4012.0305. MEMBERSHIP IN CHARITABLE ORGANIZATIONS.

district may join and pay dues to a charitable or nonprofit organization that performs a service or provides an activity

consistent with the furtherance of a district purpose.

Sec. 4012.0306. ECONOMIC DEVELOPMENT PROGRAMS. (a) The district may engage in activities that accomplish the economic

development purposes of the district.

(b) The district may establish and provide for the administration of one or more programs to promote state or local economic development and to stimulate business and commercial activity in the district, including programs to:

(1) make loans and grants of public money; and (2) provide district personnel and services.

The district may create economic development programs (c) the exercise economic development powers provided municipalities by:

(1) Chapter 380, Local Government Code; and

(2) Subchapter A, Chapter 1509, Government Code. Sec. 4012.0307. PARKING FACILITIES. (a) The district may acquire, lease as lessor or lessee, construct, develop, own, operate, and maintain parking facilities or a system of parking facilities, including lots, garages, parking terminals, or other structures or accommodations for parking motor vehicles off the streets and related appurtenances.

- (b) The district's parking facilities serve the public purposes of the district and are owned, used, and held for a public serve the public purpose even if leased or operated by a private entity for a term of years.
 - (c) The district's parking facilities are parts of and necessary components of a street and are considered to be a street or road improvement.

The development and operation of the district's parking facilities may be considered an economic development program.

Sec. 4012.0308. DISBURSEMENTS AND TRANSFERS OF MONEY. The by resolution shall establish the number of directors' The signatures and the procedure required for a disbursement οr transfer of district money.

Sec. 4012.0309. ADDING OR EXCLUDING LAND. Except as provided by Section 4012.0310, the district may add or exclude land in the manner provided by Subchapter J, Chapter 49, Water Code, or by Subchapter H, Chapter 54, Water Code.

Sec. 4012.0310. DIVISION OF DISTRICT. (a) The district may be divided into two or more new districts only if the district:

has no outstanding bonded debt; and is not imposing ad valorem taxes.

This chapter applies to any new district created by the division of the district, and a new district has all the powers and duties of the district.

(c) Any new district created by the division of the district may not, at the time the new district is created, contain any land outside the area described by Section 2 of the Act enacting this

The board, on its own motion or on receipt of a petition (d) signed by the owner or owners of a majority of the assessed value of the real property in the district, may adopt an order dividing the district.

An order dividing the district must: (e)
