5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 4, Special District Local Laws
7	Code, is amended by adding Chapter 4205 to read as follows:
8	CHAPTER 4205. FANNIN COUNTY IMPROVEMENT DISTRICT NO. 1
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 4205.0101. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "County" means Fannin County.
13	(3) "Director" means a board member.
14	(4) "District" means the Fannin County Improvement
15	District No. 1.
16	Sec. 4205.0102. NATURE OF DISTRICT. The Fannin County
17	Improvement District No. 1 is a special district created under
18	Section 59, Article XVI, Texas Constitution.
19	Sec. 4205.0103. PURPOSE; DECLARATION OF INTENT. (a) The
20	creation of the district is essential to accomplish the purposes of
21	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
22	Texas Constitution, and other public purposes stated in this
23	<pre>chapter.</pre>
24	(b) By creating the district and in authorizing the county

- 1 and other political subdivisions to contract with the district, the
- 2 legislature has established a program to accomplish the public
- 3 purposes set out in Section 52-a, Article III, Texas Constitution.
- 4 (c) The creation of the district is necessary to promote,
- 5 develop, encourage, and maintain employment, commerce,
- 6 transportation, housing, tourism, recreation, the arts,
- 7 entertainment, economic development, safety, and the public
- 8 welfare in the district.
- 9 (d) This chapter and the creation of the district may not be
- 10 interpreted to relieve the county from providing the level of
- 11 services provided as of the effective date of the Act enacting this
- 12 chapter to the area in the district. The district is created to
- 13 supplement and not to supplant county services provided in the
- 14 district.
- 15 Sec. 4205.0104. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 16 (a) All land and other property included in the district will
- 17 benefit from the improvements and services to be provided by the
- 18 district under powers conferred by Sections 52 and 52-a, Article
- 19 III, and Section 59, Article XVI, Texas Constitution, and other
- 20 powers granted under this chapter.
- 21 (b) The district is created to serve a public use and
- 22 benefit.
- (c) The creation of the district is in the public interest
- 24 and is essential to further the public purposes of:
- (1) developing and diversifying the economy of the
- 26 state;
- 27 (2) eliminating unemployment and underemployment; and

1 (3) developing or expanding transportation and 2 commerce. 3 (d) The district will: (1) promote the health, safety, and general welfare of 4 residents, employers, potential employees, employees, visitors, 5 and consumers in the district, and of the public; 6 7 (2) provide needed funding for the district to preserve, maintain, and enhance the economic health and vitality of 8 9 the district territory as a community and business center; (3) promote the health, safety, welfare, and enjoyment 10 11 of the public by providing pedestrian ways and by landscaping and developing certain areas in the district, which are necessary for 12 13 the restoration, preservation, and enhancement of scenic beauty; 14 and 15 (4) provide for water, wastewater, drainage, road, and 16 recreational facilities for the district. 17 (e) Pedestrian ways along or across a street, whether at grade or above or below the surface, and street lighting, street 18 landscaping, parking, and street art objects are parts of and 19 20 necessary components of a street and are considered to be a street 21 or road improvement. 22 The district will not act as the agent or (f)23 instrumentality of any private interest even though the district 24 will benefit many private interests as well as the public. 25 Sec. 4205.0105. INITIAL DISTRICT TERRITORY. (a)

district is initially composed of the territory described by

Section 2 of the Act enacting this chapter.

- 1 (b) The boundaries and field notes contained in Section 2 of
- 2 the Act enacting this chapter form a closure. A mistake in the
- 3 field notes or in copying the field notes in the legislative process
- 4 does not affect the district's:
- 5 (1) organization, existence, or validity;
- 6 (2) right to issue any type of bonds for the purposes
- 7 for which the district is created or to pay the principal of and
- 8 interest on the bonds;
- 9 (3) right to impose or collect an assessment or tax; or
- 10 (4) legality or operation.
- 11 Sec. 4205.0106. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 12 All or any part of the area of the district is eligible to be
- 13 included in:
- 14 (1) a tax increment reinvestment zone created under
- 15 Chapter 311, Tax Code; or
- 16 (2) a tax abatement reinvestment zone created under
- 17 Chapter 312, Tax Code.
- 18 Sec. 4205.0107. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 19 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 20 Chapter 375, Local Government Code, applies to the district.
- Sec. 4205.0108. CONSTRUCTION OF CHAPTER. This chapter
- 22 shall be liberally construed in conformity with the findings and
- 23 purposes stated in this chapter.
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 4205.0201. GOVERNING BODY; TERMS. (a) The district is
- 26 governed by a board of five voting directors elected or appointed as
- 27 provided by this chapter and Subchapter D, Chapter 49, Water Code.

- 1 (b) Except as provided by Section 4205.0203, voting
- 2 directors serve staggered four-year terms.
- 3 Sec. 4205.0202. COMPENSATION. (a) A director is entitled
- 4 to receive fees of office and reimbursement for actual expenses as
- 5 provided by Section 49.060, Water Code.
- 6 (b) Sections 375.069 and 375.070, Local Government Code, do
- 7 not apply to the board.
- 8 Sec. 4205.0203. TEMPORARY DIRECTORS. (a) On or after the
- 9 effective date of the Act enacting this chapter, the owner or owners
- 10 of a majority of the assessed value of the real property in the
- 11 district according to the most recent certified tax appraisal roll
- 12 for the county may submit a petition to the Texas Commission on
- 13 Environmental Quality requesting that the commission appoint as
- 14 temporary voting directors the five persons named in the petition.
- 15 The commission shall appoint as temporary voting directors the five
- 16 persons named in the petition.
- 17 (b) The temporary voting or successor temporary voting
- 18 directors shall hold an election to elect five permanent voting
- 19 directors as provided by Section 4205.0201.
- 20 (c) Temporary voting directors serve until the earlier of:
- 21 (1) the date permanent voting directors are elected
- 22 under Subsection (b); or
- (2) the fourth anniversary of the effective date of
- 24 the Act enacting this chapter.
- 25 (d) If permanent voting directors have not been elected
- 26 under Subsection (b) and the terms of the temporary voting
- 27 directors have expired, successor temporary voting directors shall

- 1 be appointed or reappointed as provided by Subsection (e) to serve
- 2 terms that expire on the earlier of:
- 3 (1) the date permanent voting directors are elected
- 4 under Subsection (b); or
- 5 (2) the fourth anniversary of the date of the
- 6 appointment or reappointment.
- 7 (e) If Subsection (d) applies, the owner or owners of a
- 8 majority of the assessed value of the real property in the district
- 9 according to the most recent certified tax appraisal roll for the
- 10 county may submit a petition to the Texas Commission on
- 11 Environmental Quality requesting that the commission appoint as
- 12 successor temporary voting directors the five persons named in the
- 13 petition. The commission shall appoint as successor temporary
- 14 voting directors the five persons named in the petition.
- Sec. 4205.0204. NONVOTING DIRECTORS. The board may appoint
- 16 nonvoting directors to serve at the pleasure of the voting
- 17 directors.
- Sec. 4205.0205. QUORUM. For purposes of determining the
- 19 requirements for a quorum of the board, the following are not
- 20 counted:
- 21 (1) a board position vacant for any reason, including
- 22 death, resignation, or disqualification;
- (2) a director who is abstaining from participation in
- 24 <u>a vote because of a conflict of interest; or</u>
- 25 (3) a nonvoting director.
- 26 <u>SUBCHAPTER C. POWERS AND DUTIES</u>
- Sec. 4205.0301. GENERAL POWERS AND DUTIES. The district

- 1 has the powers and duties necessary to accomplish the purposes for
- 2 which the district is created.
- 3 Sec. 4205.0302. IMPROVEMENT PROJECTS AND SERVICES. (a) The
- 4 district, using any money available to the district for the
- 5 purpose, may provide, design, construct, acquire, improve,
- 6 relocate, operate, maintain, or finance an improvement project or
- 7 service authorized under this chapter or Chapter 375, Local
- 8 Government Code.
- 9 (b) The district may contract with a governmental or private
- 10 entity to carry out an action under Subsection (a).
- 11 <u>(c) The implementation of a district project or service is a</u>
- 12 governmental function or service for the purposes of Chapter 791,
- 13 Government Code.
- 14 Sec. 4205.0303. LAW ENFORCEMENT SERVICES. To protect the
- 15 public interest, the district may contract with a qualified party,
- 16 including the county, to provide law enforcement services in the
- 17 <u>district for a fee.</u>
- 18 Sec. 4205.0304. MEMBERSHIP IN CHARITABLE ORGANIZATIONS.
- 19 The district may join and pay dues to a charitable or nonprofit
- 20 organization that performs a service or provides an activity
- 21 consistent with the furtherance of a district purpose.
- 22 Sec. 4205.0305. ECONOMIC DEVELOPMENT PROGRAMS. (a) The
- 23 <u>district may engage in activities that accomplish the economic</u>
- 24 development purposes of the district.
- 25 (b) The district may establish and provide for the
- 26 <u>administration of one or more programs to promote state or local</u>
- 27 economic development and to stimulate business and commercial

- 1 activity in the district, including programs to:
- 2 (1) make loans and grants of public money; and
- 3 (2) provide district personnel and services.
- 4 (c) The district may create economic development programs
- 5 and exercise the economic development powers provided to
- 6 municipalities by:
- 7 (1) Chapter 380, Local Government Code; and
- 8 (2) Subchapter A, Chapter 1509, Government Code.
- 9 Sec. 4205.0306. PARKING FACILITIES. (a) The district may
- 10 acquire, lease as lessor or lessee, construct, develop, own,
- 11 operate, and maintain parking facilities or a system of parking
- 12 <u>facilities</u>, including lots, garages, parking terminals, or other
- 13 structures or accommodations for parking motor vehicles off the
- 14 streets and related appurtenances.
- 15 (b) The district's parking facilities serve the public
- 16 purposes of the district and are owned, used, and held for a public
- 17 purpose even if leased or operated by a private entity for a term of
- 18 years.
- 19 (c) The district's parking facilities are parts of and
- 20 necessary components of a street and are considered to be a street
- 21 or road improvement.
- 22 (d) The development and operation of the district's parking
- 23 facilities may be considered an economic development program.
- Sec. 4205.0307. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 25 board by resolution shall establish the number of directors'
- 26 signatures and the procedure required for a disbursement or
- 27 transfer of district money.

- 1 Sec. 4205.0308. ADDING OR EXCLUDING LAND. The district may
- 2 add or exclude land in the manner provided by Subchapter J, Chapter
- 3 49, Water Code, or by Subchapter H, Chapter 54, Water Code.
- 4 Sec. 4205.0309. NAVIGATION DISTRICT POWERS. (a) The
- 5 district has the powers provided by the general law of this state
- 6 applicable to navigation districts created under Section 59,
- 7 Article XVI, Texas Constitution, including Chapters 60 and 62,
- 8 Water Code.
- 9 (b) The district may purchase, construct, acquire, own,
- 10 operate, maintain, improve, or extend, inside and outside the
- 11 district, a canal, waterway, bulkhead, dock, or other improvement
- 12 or facility necessary or convenient to accomplish the navigation
- 13 purposes of the district.
- 14 Sec. 4205.0310. NO EMINENT DOMAIN POWER. The district may
- 15 not exercise the power of eminent domain.
- SUBCHAPTER D. ASSESSMENTS
- 17 Sec. 4205.0401. PETITION REQUIRED FOR FINANCING SERVICES
- 18 AND IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
- 19 service or improvement project with assessments under this chapter
- 20 unless a written petition requesting that service or improvement
- 21 has been filed with the board.
- 22 (b) A petition filed under Subsection (a) must be signed by
- 23 the owners of a majority of the assessed value of real property in
- 24 the district subject to assessment according to the most recent
- 25 certified tax appraisal roll for the county.
- Sec. 4205.0402. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 27 The board by resolution may impose and collect an assessment for any

- 1 purpose authorized by this chapter in all or any part of the
- 2 <u>district.</u>
- 3 (b) An assessment, a reassessment, or an assessment
- 4 resulting from an addition to or correction of the assessment roll
- 5 by the district, penalties and interest on an assessment or
- 6 reassessment, an expense of collection, and reasonable attorney's
- 7 fees incurred by the district:
- 8 (1) are a first and prior lien against the property
- 9 assessed;
- 10 (2) are superior to any other lien or claim other than
- 11 <u>a lien or claim for county, school district, or municipal ad valorem</u>
- 12 taxes; and
- 13 (3) are the personal liability of and a charge against
- 14 the owners of the property even if the owners are not named in the
- 15 assessment proceedings.
- 16 <u>(c) The lien is effective from the date of the board's</u>
- 17 resolution imposing the assessment until the date the assessment is
- 18 paid. The board may enforce the lien in the same manner that the
- 19 board may enforce an ad valorem tax lien against real property.
- 20 (d) The board may make a correction to or deletion from the
- 21 assessment roll that does not increase the amount of assessment of
- 22 any parcel of land without providing notice and holding a hearing in
- 23 <u>the manner required for additional assessments.</u>
- 24 <u>SUBCHAPTER E. TAXES AND BONDS</u>
- Sec. 4205.0501. TAX ELECTION REQUIRED. (a) The district
- 26 must hold an election in the manner provided by Chapter 49, Water
- 27 Code, or, if applicable, Chapter 375, Local Government Code, to

- 1 obtain voter approval before the district may impose an ad valorem
- 2 <u>tax.</u>
- 3 (b) Section 375.243, Local Government Code, does not apply
- 4 to the district.
- 5 Sec. 4205.0502. OPERATION AND MAINTENANCE TAX. (a) If
- 6 authorized by a majority of the district voters voting at an
- 7 election under Section 4205.0501, the district may impose an
- 8 operation and maintenance tax on taxable property in the district
- 9 in the manner provided by Section 49.107, Water Code, for any
- 10 district purpose, including to:
- 11 (1) maintain and operate the district;
- 12 (2) construct or acquire improvements; or
- 13 (3) provide a service.
- 14 (b) The board shall determine the operation and maintenance
- 15 tax rate. The rate may not exceed the rate approved at the
- 16 <u>election</u>.
- 17 Sec. 4205.0503. AUTHORITY TO BORROW MONEY AND TO ISSUE
- 18 BONDS AND OTHER OBLIGATIONS. (a) The district may borrow money on
- 19 terms determined by the board.
- 20 (b) The district may issue bonds, notes, or other
- 21 obligations payable wholly or partly from ad valorem taxes,
- 22 assessments, impact fees, revenue, contract payments, grants, or
- 23 other district money, or any combination of those sources of money,
- 24 to pay for any authorized district purpose.
- Sec. 4205.0504. BONDS SECURED BY REVENUE OR CONTRACT
- 26 PAYMENTS. The district may issue, without an election, bonds
- 27 secured by:

- 1 (1) revenue other than ad valorem taxes, including
- 2 contract revenues; or
- 3 (2) contract payments, provided that the requirements
- 4 of Section 49.108, Water Code, have been met.
- 5 Sec. 4205.0505. BONDS SECURED BY AD VALOREM TAXES;
- 6 ELECTIONS. (a) If authorized at an election under Section
- 7 4205.0501, the district may issue bonds payable from ad valorem
- 8 taxes.
- 9 (b) At the time the district issues bonds payable wholly or
- 10 partly from ad valorem taxes, the board shall provide for the annual
- 11 imposition of a continuing direct annual ad valorem tax, without
- 12 limit as to rate or amount, for each year that all or part of the
- 13 bonds are outstanding as required and in the manner provided by
- 14 Sections 54.601 and 54.602, Water Code.
- 15 (c) All or any part of any facilities or improvements that
- 16 may be acquired by a district by the issuance of its bonds may be
- 17 <u>submitted as a single proposition or as several propositions to be</u>
- 18 voted on at the election.
- 19 Sec. 4205.0506. CONSENT OF MUNICIPALITY REQUIRED. (a) The
- 20 board may not issue bonds until each municipality in whose
- 21 corporate limits or extraterritorial jurisdiction the district is
- 22 located has consented by ordinance or resolution to the creation of
- 23 the district and to the inclusion of land in the district as
- 24 required by applicable law.
- 25 (b) This section applies only to the district's first
- 26 issuance of bonds payable from ad valorem taxes.

1 SUBCHAPTER I. DISSOLUTION

- Sec. 4205.0901. DISSOLUTION. (a) The board shall dissolve
- 3 the district on written petition filed with the board by the owners
- 4 of at least two-thirds of the assessed value of the property subject
- 5 to assessment or taxation by the district based on the most recent
- 6 certified county property tax rolls.
- 7 (b) The board by majority vote may dissolve the district at
- 8 any time.
- 9 <u>(c) The district may not be dissolved by its board under</u>
- 10 Subsection (a) or (b) if the district:
- 11 (1) has any outstanding bonded indebtedness until that
- 12 bonded indebtedness has been repaid or defeased in accordance with
- 13 the order or resolution authorizing the issuance of the bonds;
- 14 (2) has a contractual obligation to pay money until
- 15 that obligation has been fully paid in accordance with the
- 16 contract; or
- 17 (3) owns, operates, or maintains public works,
- 18 facilities, or improvements unless the district contracts with
- 19 another person for the ownership, operation, or maintenance of the
- 20 public works, facilities, or improvements.
- 21 (d) Sections 375.261, 375.262, and 375.264, Local
- 22 Government Code, do not apply to the district.
- 23 SECTION 2. The Fannin County Improvement District No. 1
- 24 initially includes all territory contained in the following area:
- 25 BEING a 337.65 acre (14,707,855 square feet) tract of land,
- 26 situated in the Daniel Davis Survey, Abstract No. 269, John Nail
- 27 Survey, Abstract No. 842, William Perrin Survey, Abstract No. 873

- and the William Lewis Survey, Abstract No. 649, Fannin County 1 2 Texas, and being part of a called 56.605 acre tract of land referred to as Johnson Family Trust (Tract Ten "Parcel J"), part of a called 3 57.544 acre tract, (Tract Ten "Parcel I"), part of a called 76 acre 4 tract, (Tract Ten "Parcel A"), all of a called 39.5 acre tract 5 (Tract 10 "Parcel B"), part of a called 66.050 acre tract (Tract 10 6 7 "Parcel F"), all of a called 55 acre tract (Tract Fourteen), all of a called 52 acre tract, (Tract Twelve "Parcel B"), all of a called 8 9 50 acre tract (Tract Twelve "Parcel C"), part of a called 50 acre tract (Tract Twelve "Parcel D"), all of a called 2-1/2 acre tract 10 11 (Tract Twelve "Parcel E"), described in a Warranty Deed to Loyd D. - 27 SECTION 4. This Act takes effect immediately if it receives

- 1 a vote of two-thirds of all the members elected to each house, as
- 2 provided by Section 39, Article III, Texas Constitution. If this
- 3 Act does not receive the vote necessary for immediate effect, this
- 4 Act takes effect September 1, 2025.
