S.B. No. 3050

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Fannin County Improvement District No. 1; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle C, Title 4, Special District Local Laws Code, is amended by adding Chapter 4205 to read as follows:

CHAPTER 4205. FANNIN COUNTY IMPROVEMENT DISTRICT NO. 1

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 4205.0101. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "County" means Fannin County.

(3) "Director" means a board member.

(4) "District" means the Fannin County Improvement District No. 1.

Sec. 4205.0102. NATURE OF DISTRICT. The Fannin County Improvement District No. 1 is a special district created under Section 59, Article XVI, Texas Constitution.

Sec. 4205.0103. PURPOSE; DECLARATION OF INTENT. (a) The creation of the district is essential to accomplish the purposes of Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other public purposes stated in this chapter.

(b) By creating the district and in authorizing the county

1 and other political subdivisions to contract with the district, the  
2 legislature has established a program to accomplish the public  
3 purposes set out in Section 52-a, Article III, Texas Constitution.

4 (c) The creation of the district is necessary to promote,  
5 develop, encourage, and maintain employment, commerce,  
6 transportation, housing, tourism, recreation, the arts,  
7 entertainment, economic development, safety, and the public  
8 welfare in the district.

9 (d) This chapter and the creation of the district may not be  
10 interpreted to relieve the county from providing the level of  
11 services provided as of the effective date of the Act enacting this  
12 chapter to the area in the district. The district is created to  
13 supplement and not to supplant county services provided in the  
14 district.

15 Sec. 4205.0104. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.

16 (a) All land and other property included in the district will  
17 benefit from the improvements and services to be provided by the  
18 district under powers conferred by Sections 52 and 52-a, Article  
19 III, and Section 59, Article XVI, Texas Constitution, and other  
20 powers granted under this chapter.

21 (b) The district is created to serve a public use and  
22 benefit.

23 (c) The creation of the district is in the public interest  
24 and is essential to further the public purposes of:

25 (1) developing and diversifying the economy of the  
26 state;

27 (2) eliminating unemployment and underemployment; and

1           (3) developing or expanding transportation and  
2 commerce.

3           (d) The district will:

4           (1) promote the health, safety, and general welfare of  
5 residents, employers, potential employees, employees, visitors,  
6 and consumers in the district, and of the public;

7           (2) provide needed funding for the district to  
8 preserve, maintain, and enhance the economic health and vitality of  
9 the district territory as a community and business center;

10           (3) promote the health, safety, welfare, and enjoyment  
11 of the public by providing pedestrian ways and by landscaping and  
12 developing certain areas in the district, which are necessary for  
13 the restoration, preservation, and enhancement of scenic beauty;  
14 and

15           (4) provide for water, wastewater, drainage, road, and  
16 recreational facilities for the district.

17           (e) Pedestrian ways along or across a street, whether at  
18 grade or above or below the surface, and street lighting, street  
19 landscaping, parking, and street art objects are parts of and  
20 necessary components of a street and are considered to be a street  
21 or road improvement.

22           (f) The district will not act as the agent or  
23 instrumentality of any private interest even though the district  
24 will benefit many private interests as well as the public.

25           Sec. 4205.0105. INITIAL DISTRICT TERRITORY. (a) The  
26 district is initially composed of the territory described by  
27 Section 2 of the Act enacting this chapter.

1        (b) The boundaries and field notes contained in Section 2 of  
2 the Act enacting this chapter form a closure. A mistake in the  
3 field notes or in copying the field notes in the legislative process  
4 does not affect the district's:

5            (1) organization, existence, or validity;

6            (2) right to issue any type of bonds for the purposes  
7 for which the district is created or to pay the principal of and  
8 interest on the bonds;

9            (3) right to impose or collect an assessment or tax; or

10           (4) legality or operation.

11        Sec. 4205.0106. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.  
12 All or any part of the area of the district is eligible to be  
13 included in:

14           (1) a tax increment reinvestment zone created under  
15 Chapter 311, Tax Code; or

16           (2) a tax abatement reinvestment zone created under  
17 Chapter 312, Tax Code.

18        Sec. 4205.0107. APPLICABILITY OF MUNICIPAL MANAGEMENT  
19 DISTRICTS LAW. Except as otherwise provided by this chapter,  
20 Chapter 375, Local Government Code, applies to the district.

21        Sec. 4205.0108. CONSTRUCTION OF CHAPTER. This chapter  
22 shall be liberally construed in conformity with the findings and  
23 purposes stated in this chapter.

24            SUBCHAPTER B. BOARD OF DIRECTORS

25        Sec. 4205.0201. GOVERNING BODY; TERMS. (a) The district is  
26 governed by a board of five voting directors elected or appointed as  
27 provided by this chapter and Subchapter D, Chapter 49, Water Code.

1        (b) Except as provided by Section 4205.0203, voting  
2 directors serve staggered four-year terms.

3        Sec. 4205.0202. COMPENSATION. (a) A director is entitled  
4 to receive fees of office and reimbursement for actual expenses as  
5 provided by Section 49.060, Water Code.

6        (b) Sections 375.069 and 375.070, Local Government Code, do  
7 not apply to the board.

8        Sec. 4205.0203. TEMPORARY DIRECTORS. (a) On or after the  
9 effective date of the Act enacting this chapter, the owner or owners  
10 of a majority of the assessed value of the real property in the  
11 district according to the most recent certified tax appraisal roll  
12 for the county may submit a petition to the Texas Commission on  
13 Environmental Quality requesting that the commission appoint as  
14 temporary voting directors the five persons named in the petition.  
15 The commission shall appoint as temporary voting directors the five  
16 persons named in the petition.

17        (b) The temporary voting or successor temporary voting  
18 directors shall hold an election to elect five permanent voting  
19 directors as provided by Section 4205.0201.

20        (c) Temporary voting directors serve until the earlier of:

21            (1) the date permanent voting directors are elected  
22 under Subsection (b); or

23            (2) the fourth anniversary of the effective date of  
24 the Act enacting this chapter.

25        (d) If permanent voting directors have not been elected  
26 under Subsection (b) and the terms of the temporary voting  
27 directors have expired, successor temporary voting directors shall

1 be appointed or reappointed as provided by Subsection (e) to serve  
2 terms that expire on the earlier of:

3 (1) the date permanent voting directors are elected  
4 under Subsection (b); or

5 (2) the fourth anniversary of the date of the  
6 appointment or reappointment.

7 (e) If Subsection (d) applies, the owner or owners of a  
8 majority of the assessed value of the real property in the district  
9 according to the most recent certified tax appraisal roll for the  
10 county may submit a petition to the Texas Commission on  
11 Environmental Quality requesting that the commission appoint as  
12 successor temporary voting directors the five persons named in the  
13 petition. The commission shall appoint as successor temporary  
14 voting directors the five persons named in the petition.

15 Sec. 4205.0204. NONVOTING DIRECTORS. The board may appoint  
16 nonvoting directors to serve at the pleasure of the voting  
17 directors.

18 Sec. 4205.0205. QUORUM. For purposes of determining the  
19 requirements for a quorum of the board, the following are not  
20 counted:

21 (1) a board position vacant for any reason, including  
22 death, resignation, or disqualification;

23 (2) a director who is abstaining from participation in  
24 a vote because of a conflict of interest; or

25 (3) a nonvoting director.

26 SUBCHAPTER C. POWERS AND DUTIES

27 Sec. 4205.0301. GENERAL POWERS AND DUTIES. The district

has the powers and duties necessary to accomplish the purposes for which the district is created.

Sec. 4205.0302. IMPROVEMENT PROJECTS AND SERVICES. (a) The district, using any money available to the district for the purpose, may provide, design, construct, acquire, improve, relocate, operate, maintain, or finance an improvement project or service authorized under this chapter or Chapter 375, Local Government Code.

(b) The district may contract with a governmental or private entity to carry out an action under Subsection (a).

(c) The implementation of a district project or service is a governmental function or service for the purposes of Chapter 791, Government Code.

Sec. 4205.0303. LAW ENFORCEMENT SERVICES. To protect the public interest, the district may contract with a qualified party, including the county, to provide law enforcement services in the district for a fee.

Sec. 4205.0304. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The district may join and pay dues to a charitable or nonprofit organization that performs a service or provides an activity consistent with the furtherance of a district purpose.

Sec. 4205.0305. ECONOMIC DEVELOPMENT PROGRAMS. (a) The district may engage in activities that accomplish the economic development purposes of the district.

(b) The district may establish and provide for the administration of one or more programs to promote state or local economic development and to stimulate business and commercial

activity in the district, including programs to:

(1) make loans and grants of public money; and

(2) provide district personnel and services.

(c) The district may create economic development programs and exercise the economic development powers provided to municipalities by:

(1) Chapter 380, Local Government Code; and

(2) Subchapter A, Chapter 1509, Government Code.

Sec. 4205.0306. PARKING FACILITIES. (a) The district may acquire, lease as lessor or lessee, construct, develop, own, operate, and maintain parking facilities or a system of parking facilities, including lots, garages, parking terminals, or other structures or accommodations for parking motor vehicles off the streets and related appurtenances.

(b) The district's parking facilities serve the public purposes of the district and are owned, used, and held for a public purpose even if leased or operated by a private entity for a term of years.

(c) The district's parking facilities are parts of and necessary components of a street and are considered to be a street or road improvement.

(d) The development and operation of the district's parking facilities may be considered an economic development program.

Sec. 4205.0307. DISBURSEMENTS AND TRANSFERS OF MONEY. The board by resolution shall establish the number of directors' signatures and the procedure required for a disbursement or transfer of district money.



1       Sec. 4205.0308. ADDING OR EXCLUDING LAND. The district may  
2 add or exclude land in the manner provided by Subchapter J, Chapter  
3 49, Water Code, or by Subchapter H, Chapter 54, Water Code.

4       Sec. 4205.0309. NAVIGATION DISTRICT POWERS. (a) The  
5 district has the powers provided by the general law of this state  
6 applicable to navigation districts created under Section 59,  
7 Article XVI, Texas Constitution, including Chapters 60 and 62,  
8 Water Code.

9       (b) The district may purchase, construct, acquire, own,  
10 operate, maintain, improve, or extend, inside and outside the  
11 district, a canal, waterway, bulkhead, dock, or other improvement  
12 or facility necessary or convenient to accomplish the navigation  
13 purposes of the district.

14       Sec. 4205.0310. NO EMINENT DOMAIN POWER. The district may  
15 not exercise the power of eminent domain.

16                   SUBCHAPTER D. ASSESSMENTS

17       Sec. 4205.0401. PETITION REQUIRED FOR FINANCING SERVICES  
18 AND IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a  
19 service or improvement project with assessments under this chapter  
20 unless a written petition requesting that service or improvement  
21 has been filed with the board.

22       (b) A petition filed under Subsection (a) must be signed by  
23 the owners of a majority of the assessed value of real property in  
24 the district subject to assessment according to the most recent  
25 certified tax appraisal roll for the county.

26       Sec. 4205.0402. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)  
27 The board by resolution may impose and collect an assessment for any

purpose authorized by this chapter in all or any part of the district.

(b) An assessment, a reassessment, or an assessment resulting from an addition to or correction of the assessment roll by the district, penalties and interest on an assessment or reassessment, an expense of collection, and reasonable attorney's fees incurred by the district:

(1) are a first and prior lien against the property assessed;

(2) are superior to any other lien or claim other than a lien or claim for county, school district, or municipal ad valorem taxes; and

(3) are the personal liability of and a charge against the owners of the property even if the owners are not named in the assessment proceedings.

(c) The lien is effective from the date of the board's resolution imposing the assessment until the date the assessment is paid. The board may enforce the lien in the same manner that the board may enforce an ad valorem tax lien against real property.

(d) The board may make a correction to or deletion from the assessment roll that does not increase the amount of assessment of any parcel of land without providing notice and holding a hearing in the manner required for additional assessments.

#### SUBCHAPTER E. TAXES AND BONDS

Sec. 4205.0501. TAX ELECTION REQUIRED. (a) The district must hold an election in the manner provided by Chapter 49, Water Code, or, if applicable, Chapter 375, Local Government Code, to

obtain voter approval before the district may impose an ad valorem tax.

(b) Section 375.243, Local Government Code, does not apply to the district.

Sec. 4205.0502. OPERATION AND MAINTENANCE TAX. (a) If authorized by a majority of the district voters voting at an election under Section 4205.0501, the district may impose an operation and maintenance tax on taxable property in the district in the manner provided by Section 49.107, Water Code, for any district purpose, including to:

(1) maintain and operate the district;

(2) construct or acquire improvements; or

(3) provide a service.

(b) The board shall determine the operation and maintenance tax rate. The rate may not exceed the rate approved at the election.

Sec. 4205.0503. AUTHORITY TO BORROW MONEY AND TO ISSUE BONDS AND OTHER OBLIGATIONS. (a) The district may borrow money on terms determined by the board.

(b) The district may issue bonds, notes, or other obligations payable wholly or partly from ad valorem taxes, assessments, impact fees, revenue, contract payments, grants, or other district money, or any combination of those sources of money, to pay for any authorized district purpose.

Sec. 4205.0504. BONDS SECURED BY REVENUE OR CONTRACT PAYMENTS. The district may issue, without an election, bonds secured by:

1           (1) revenue other than ad valorem taxes, including  
2 contract revenues; or

3           (2) contract payments, provided that the requirements  
4 of Section 49.108, Water Code, have been met.

5           Sec. 4205.0505. BONDS SECURED BY AD VALOREM TAXES;  
6 ELECTIONS. (a) If authorized at an election under Section  
7 4205.0501, the district may issue bonds payable from ad valorem  
8 taxes.

9           (b) At the time the district issues bonds payable wholly or  
10 partly from ad valorem taxes, the board shall provide for the annual  
11 imposition of a continuing direct annual ad valorem tax, without  
12 limit as to rate or amount, for each year that all or part of the  
13 bonds are outstanding as required and in the manner provided by  
14 Sections 54.601 and 54.602, Water Code.

15           (c) All or any part of any facilities or improvements that  
16 may be acquired by a district by the issuance of its bonds may be  
17 submitted as a single proposition or as several propositions to be  
18 voted on at the election.

19           Sec. 4205.0506. CONSENT OF MUNICIPALITY REQUIRED. (a) The  
20 board may not issue bonds until each municipality in whose  
21 corporate limits or extraterritorial jurisdiction the district is  
22 located has consented by ordinance or resolution to the creation of  
23 the district and to the inclusion of land in the district as  
24 required by applicable law.

25           (b) This section applies only to the district's first  
26 issuance of bonds payable from ad valorem taxes.

SUBCHAPTER I. DISSOLUTION

Sec. 4205.0901. DISSOLUTION. (a) The board shall dissolve the district on written petition filed with the board by the owners of at least two-thirds of the assessed value of the property subject to assessment or taxation by the district based on the most recent certified county property tax rolls.

(b) The board by majority vote may dissolve the district at any time.

(c) The district may not be dissolved by its board under Subsection (a) or (b) if the district:

(1) has any outstanding bonded indebtedness until that bonded indebtedness has been repaid or defeased in accordance with the order or resolution authorizing the issuance of the bonds;

(2) has a contractual obligation to pay money until that obligation has been fully paid in accordance with the contract; or

(3) owns, operates, or maintains public works, facilities, or improvements unless the district contracts with another person for the ownership, operation, or maintenance of the public works, facilities, or improvements.

(d) Sections 375.261, 375.262, and 375.264, Local Government Code, do not apply to the district.

SECTION 2. The Fannin County Improvement District No. 1 initially includes all territory contained in the following area:

2 Texas, and being part of a called 56.605 acre tract of land referred  
3 to as Johnson Family Trust (Tract Ten "Parcel J"), part of a called  
4 57.544 acre tract, (Tract Ten "Parcel I"), part of a called 76 acre  
5 tract, (Tract Ten "Parcel A"), all of a called 39.5 acre tract  
6 (Tract 10 "Parcel B"), part of a called 66.050 acre tract (Tract 10  
7 "Parcel F"), all of a called 55 acre tract (Tract Fourteen), all of  
8 a called 52 acre tract, (Tract Twelve "Parcel B"), all of a called  
9 50 acre tract (Tract Twelve "Parcel C"), part of a called 50 acre

16       (b) The governor, one of the required recipients, has  
17 submitted the notice and Act to the Texas Commission on  
18 Environmental Quality.

19       (c) The Texas Commission on Environmental Quality has filed  
20 its recommendations relating to this Act with the governor,  
21 lieutenant governor, and speaker of the house of representatives  
22 within the required time.

23       (d) All requirements of the constitution and laws of this  
24 state and the rules and procedures of the legislature with respect  
25 to the notice, introduction, and passage of this Act have been
