10	SUBCHAPTER A. GENERAL PROVISIONS		
11	Sec. 4014.0101. DEFINITIONS. In this chapter:		
12	(1) "Board" means the district's board of directors.		
13	(2) "City" means the City of Sherman.		
14	(3) "County" means Grayson County.		
15	(4) "Director" means a board member.		
16	(5) "District" means the Alluvium Ranch Municipal		
17	Management District No. 1.		
18	Sec. 4014.0102. NATURE OF DISTRICT. The Alluvium Ranch		
19	Municipal Management District No. 1 is a special district created		
20	under Section 59, Article XVI, Texas Constitution.		
21	Sec. 4014.0103. PURPOSE; DECLARATION OF INTENT. (a) The		
22	creation of the district is essential to accomplish the purposes of		
23	Sections 52 and 52-a, Article III, and Section 59, Article XVI,		
24	Texas Constitution and other nublic nurnoses stated in this		

- 1 <u>chapter</u>.
- 2 (b) By creating the district and in authorizing the city,
- 3 the county, or other political subdivisions to contract with the
- 4 district, the legislature has established a program to accomplish
- 5 the public purposes set out in Section 52-a, Article III, Texas
- 6 Constitution.
- 7 (c) The creation of the district is necessary to promote,
- 8 develop, encourage, and maintain employment, commerce,
- 9 transportation, housing, tourism, recreation, the arts,
- 10 entertainment, economic development, safety, and the public
- 11 welfare in the district.
- 12 (d) This chapter and the creation of the district may not be
- 13 interpreted to relieve the city or county from providing the level
- 14 of services provided as of the effective date of the Act enacting
- 15 this chapter to the area in the district. The district is created
- 16 to supplement and not to supplant any city or county services
- 17 provided in the district.
- 18 Sec. 4014.0104. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 19 (a) All land and other property included in the district will
- 20 benefit from the improvements and services to be provided by the
- 21 district under powers conferred by Sections 52 and 52-a, Article
- 22 III, and Section 59, Article XVI, Texas Constitution, and other
- 23 powers granted under this chapter.
- 24 <u>(b) The district is created to serve a public use and</u>
- 25 benefit.
- 26 (c) The creation of the district is in the public interest
- 27 and is essential to further the public purposes of:

1 (1) developing and diversifying the economy of the 2 state; 3 (2) eliminating unemployment and underemployment; and (3) developing or expanding transportation and 4 5 commerce. The district will: 6 (d) 7 (1) promote the health, safety, and general welfare of residents, employers, potential employees, employees, visitors, 8 9 and consumers in the district, and of the public; 10 (2) provide needed funding for the district to 11 preserve, maintain, and enhance the economic health and vitality of 12 the district territory as a community and business center; 13 (3) promote the health, safety, welfare, and enjoyment of the public by providing pedestrian ways and by landscaping and 14 developing certain areas in the district, which are necessary for 15 16 the restoration, preservation, and enhancement of scenic beauty; 17 and 18 (4) provide for water, wastewater, drainage, road, and recreational facilities for the district. 19 20 (e) Pedestrian ways along or across a street, whether at grade or above or below the surface, and street lighting, street 21 landscaping, parking, and street art objects are parts of and 22 23 necessary components of a street and are considered to be a street 24 or road improvement.

- 1 Sec. 4014.0105. INITIAL DISTRICT TERRITORY. (a) The
- 2 district is initially composed of the territory described by
- 3 Section 2 of the Act enacting this chapter.
- 4 (b) The boundaries and field notes contained in Section 2 of
- 5 the Act enacting this chapter form a closure. A mistake in the
- 6 field notes or in copying the field notes in the legislative process
- 7 does not affect the district's:
- 8 (1) organization, existence, or validity;
- 9 (2) right to issue any type of bonds for the purposes

- Sec. 4014.0107. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 22 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 23 Chapter 375, Local Government Code, applies to the district.
- Sec. 4014.0108. CONSTRUCTION OF CHAPTER. This chapter
- 25 shall be liberally construed in conformity with the findings and
- 26 purposes stated in this chapter.

1	SUBCHAPTER B. BOARD OF DIRECTORS		
2	Sec. 4014.0201. GOVERNING BODY; TERMS. (a) The district is		
3	governed by a board of five elected directors who serve staggered		
4	terms of four years.		
5	(b) Directors are elected in the manner provided by		
6	Subchapter D, Chapter 49, Water Code.		
7	Sec. 4014.0202. COMPENSATION; EXPENSES. (a) The district		
8	may compensate each director in an amount not to exceed \$150 for		
9	each board meeting. The total amount of compensation for each		
10	director in one year may not exceed \$7,200.		
11	(b) A director is entitled to reimbursement for necessary		
12	and reasonable expenses incurred in carrying out the duties and		
13	responsibilities of the board.		
14	(c) Sections 375.069 and 375.070, Local Government Code, do		
15	not apply to the board.

- 2 Sec. 4014.0301. GENERAL POWERS AND DUTIES. The district
- 3 has the powers and duties necessary to accomplish the purposes for
- 4 which the district is created.
- 5 Sec. 4014.0302. IMPROVEMENT PROJECTS AND SERVICES. (a) The
- 6 district, using any money available to the district for the
- 7 purpose, may provide, design, construct, acquire, improve,
- 8 relocate, operate, maintain, or finance an improvement project or
- 9 service authorized under this chapter or under Chapter 375, Local
- 10 Government Code.
- 11 (b) The district may contract with a governmental or private
- 12 <u>entity to carry out an action under Subsection</u> (a).
- 13 (c) The implementation of a district project or service is a
- 14 governmental function or service for the purposes of Chapter 791,
- 15 Government Code.
- Sec. 4014.0303. NONPROFIT CORPORATION. (a) The board by
- 17 resolution may authorize the creation of a nonprofit corporation to
- 18 assist and act for the district in implementing a project or
- 19 providing a service authorized by this chapter.
- 20 (b) The nonprofit corporation:
- 21 (1) has each power of and is considered to be a local
- 22 government corporation created under Subchapter D, Chapter 431,
- 23 Transportation Code; and
- 24 (2) may implement any project and provide any service
- 25 authorized by this chapter.
- 26 (c) The board shall appoint the board of directors of the
- 27 nonprofit corporation. The board of directors of the nonprofit

- 1 corporation shall serve in the same manner as the board of directors
- 2 of a local government corporation created under Subchapter D,

- 17 administration of one or more programs to promote state or local
- 18 economic development and to stimulate business and commercial
- 19 activity in the district, including programs to:

- 21 (2) provide district personnel and services.
- (c) The district may create economic development programs
- 23 and exercise the economic development powers provided to
- 24 municipalities by:
- 25 (1) Chapter 380, Local Government Code; and
- 26 (2) Subchapter A, Chapter 1509, Government Code.
- Sec. 4014.0307. PARKING FACILITIES. (a) The district may

- 1 acquire, lease as lessor or lessee, construct, develop, own,
- 2 operate, and maintain parking facilities or a system of parking
- 3 facilities, including lots, garages, parking terminals, or other
- 4 structures or accommodations for parking motor vehicles off the
- 5 streets and related appurtenances.
- 6 (b) The district's parking facilities serve the public
- 7 purposes of the district and are owned, used, and held for a public
- 8 purpose even if leased or operated by a private entity for a term of
- 9 years.
- 10 (c) The district's parking facilities are parts of and
- 11 necessary components of a street and are considered to be a street
- 12 <u>or road improvement.</u>
- 13 (d) The development and operation of the district's parking
- 14 facilities may be considered an economic development program.
- 15 Sec. 4014.0308. DISBURSEMENTS AND TRANSFERS OF MONEY. The
- 16 board by resolution shall establish the number of directors'
- 17 signatures and the procedure required for a disbursement or
- 18 transfer of district money.
- 19 Sec. 4014.0309. ADDING OR EXCLUDING LAND. Except as
- 20 provided by Section 4014.0310, the district may add or exclude land
- 21 in the manner provided by Subchapter J, Chapter 49, Water Code, or
- 22 by Subchapter H, Chapter 54, Water Code.
- Sec. 4014.0310. DIVISION OF DISTRICT. (a) The district may
- 24 be divided into two or more new districts only if the district has
- 25 no outstanding bonded debt.
- 26 (b) This chapter applies to any new district created by the
- 27 division of the district, and a new district has all the powers and

- 1 duties of the district.
- 2 (c) Any new district created by the division of the district
- 3 may not, at the time the new district is created, contain any land
- 4 outside the area described by Section 2 of the Act enacting this
- 5 chapter.
- 6 (d) The board, on its own motion or on receipt of a petition
- 7 signed by the owner or owners of a majority of the assessed value of
- 8 the real property in the district, may adopt an order dividing the

- 1 (h) Any new district created by the division of the district

- 4 Sec. 4014.0311. CERTAIN RESIDENTIAL PROPERTY NOT EXEMPT.
- 5 Section 375.161, Local Government Code, does not apply to the
- 6 district.
- 7 Sec. 4014.0312. EMINENT DOMAIN. The district may exercise
- 8 the power of eminent domain in the manner provided by Section
- 9 49.222, Water Code.
- 10 SUBCHAPTER D. ASSESSMENTS
- 11 Sec. 4014.0401. PETITION REQUIRED FOR FINANCING SERVICES
- 12 AND IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
- 13 service or improvement project with assessments under this chapter
- 14 unless a written petition requesting that service or improvement
- 15 has been filed with the board.
- 16 (b) A petition filed under Subsection (a) must be signed by
- 17 the owners of a majority of the assessed value of real property in
- 18 the district subject to assessment according to the most recent
- 19 certified tax appraisal roll for the county.
- Sec. 4014.0402. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 21 The board by resolution may impose and collect an assessment for any
- 22 purpose authorized by this chapter in all or any part of the
- 23 district.
- 24 <u>(b) An assessment, a reassessment, or an assessment</u>
- 25 resulting from an addition to or correction of the assessment roll
- 26 by the district, penalties and interest on an assessment or
- 27 reassessment, an expense of collection, and reasonable attorney's

- 1 fees incurred by the district:
- 2 (1) are a first and prior lien against the property
- 3 assessed;
- 4 (2) are superior to any other lien or claim other than

- 5 (1) revenue other than ad valorem taxes, including
- 6 contract revenues; or
- 7 (2) contract payments, provided that the requirements
- 8 of Section 49.108, Water Code, have been met.
- 9 <u>Sec. 4014.0505.</u> CONSENT OF POLITICAL SUBDIVISION REQUIRED.
- 10 (a) The board may not issue bonds until each political subdivision
- 11 in which the district is located from which consent is required by
- 12 applicable general law has consented by ordinance or resolution to
- 13 the creation of the district and to the inclusion of land in the
- 14 district.
- 15 (b) This section applies only to the district's first
- 16 issuance of bonds.
- 17 SUBCHAPTER I. DISSOLUTION
- Sec. 4014.0901. DISSOLUTION. (a) The board shall dissolve
- 19 the district on written petition filed with the board by the owners

- 21 (1) at least two-thirds of the assessed value of the

- 23 recent certified county property tax rolls; or
- 24 (2) at least two-thirds of the surface area of the
- 25 district, excluding roads, streets, highways, utility

- 1 county property tax rolls.
- 2 (b) The board by majority vote may dissolve the district at
- 3 any time.
- 4 (c) The district may not be dissolved by its board under
- 5 Subsection (a) or (b) if the district:
- 6 (1) has any outstanding bonded indebtedness until that
- 7 bonded indebtedness has been repaid or defeased in accordance with
- 8 the order or resolution authorizing the issuance of the bonds;
- 9 <u>(2) has a contractual obligation to pay money until</u>
- 10 that obligation has been fully paid in accordance with the
- 11 contract; or
- 12 (3) owns, operates, or maintains public works,
- 13 facilities, or improvements unless the district contracts with
- 14 another person for the ownership, operation, or maintenance of the
- 15 public works, facilities, or improvements.
- 16 (d) Sections 375.261, 375.262, and 375.264, Local
- 17 Government Code, do not apply to the district.
- 18 SECTION 2. The Alluvium Ranch Municipal Management District
- 19 No. 1 initially includes all territory contained in the following
- 20 area:
- 21 BEING a tract of land situated in the Aaron Burleson Survey,

- 27 "Third Tract", all of a called "Fourth Tract", all of a called

- 1 "Fifth Tract", and part of a called "First Tract, described in a
- 2 deed to Carolyn Washburn Russell and husband, Gerald Eugene
- 3 Russell, as recorded in Volume 4450, Page 386, and all of a called
- 4 49.884-acre tract of land, described in a deed to Gerald Eugene
- 5 Russell and Carolyn Washburn Russell, as recorded in Instrument
- 6 No. 2018-4763, all of the Official Records, Grayson County, Texas,
- 7 and being more particularly described by metes and bounds as
- 8 follows:
- 9 BEGINNING at a 5/8-inch iron rod with red plastic cap stamped "KHA"
- 10 set for the southeast corner of said "First Tract" (V4450/P386) and
