(4) "Director" means a board member. 15 "District" means the Alluvium Ranch Municipal 16 (5) Management District No. 1. 17 Sec. 4014.0102. NATURE OF DISTRICT. The Alluvium Ranch 18 Municipal Management District No. 1 is a special district created 19 under Section 59, Article XVI, Texas Constitution. 20 21 Sec. 4014.0103. PURPOSE; DECLARATION OF INTENT. (a) The creation of the district is essential to accomplish the purposes of 22 23 Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other public purposes stated in this 24

2 (b) By creating the district and in authorizing the city, 3 the county, or other political subdivisions to contract with the 4 district, the legislature has established a program to accomplish 5 the public purposes set out in Section 52-a, Article III, Texas 6 Constitution.

7 <u>(c) The creation of the district is necessary to promote,</u> 8 <u>develop, encourage, and maintain employment, commerce,</u> 9 <u>transportation, housing, tourism, recreation, the arts,</u> 10 <u>entertainment, economic development, safety, and the public</u> 11 welfare in the district.

12 (d) This chapter and the creation of the district may not be 13 interpreted to relieve the city or county from providing the level 14 of services provided as of the effective date of the Act enacting 15 this chapter to the area in the district. The district is created 16 to supplement and not to supplant any city or county services 17 provided in the district.

19 (a) All land and other property included in the district will
20 benefit from the improvements and services to be provided by the
21 district under powers conferred by Sections 52 and 52-a, Article

23 powers granted under this chapter.

24 (b) The district is created to serve a public use and 25 <u>benefit.</u>

26 (c) The creation of the district is in the public interest
27 and is essential to further the public purposes of:

11	preserve, maintain, and enhance the economic health and vitality of

15	developing certain areas in the district, which are necessary for
16	the restoration, preservation, and enhancement of scenic beauty;

20	(e) Pedestrian ways along or across a street, whether at
21	grade or above or below the surface, and street lighting, street
22	landscaping, parking, and street art objects are parts of and
23	necessary components of a street and are considered to be a street
24	or road improvement.
25	(f) The district will not act as the agent or
26	instrumentality of any private interest even though the district
27	will benefit many private interests as well as the public.

(a) 1 The 2 district is initially composed of the territory described by 3 Section 2 of the Act enacting this chapter. 4 (b) The boundaries and field notes contained in Section 2 of 5 the Act enacting this chapter form a closure. A mistake in the field notes or in copying the field notes in the legislative process 6 7 does not affect the district's: 8 organization, existence, or validity; (2) right to issue any type of bonds for the purposes 9 for which the district is created or to pay the principal of and 10 11 interest on the bonds; 12 (3) right to impose or collect an assessment or tax; or 13 (4) legality or operation. APPLICABILITY OF MUNICIPAL MANAGEMENT DISTRICTS LAW. Except as otherwise provided by this chapter, 22 Chapter 375, Local Government Code, applies to the district. 23 24 Sec. 4014.0108. CONSTRUCTION OF CHAPTER. This chapter shall be liberally construed in conformity with the findings and 25 26 purposes stated in this chapter.

2	Sec. 4014.0201. GOVERNING BODY; TERMS. (a) The district is

2	Sec. 4014.0301. GENERAL POWERS AND DUTIES. The district

To protect the public interest, the district may contract with a qualified party, 6 7 including the city or the county, to provide law enforcement 8 services in the district for a fee. 9 Sec. 4014.0305. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. 10 The district may join and pay dues to a charitable or nonprofit organization that performs a service or provides an activity 11 12 consistent with the furtherance of a district purpose. Sec. 4014.0306. ECONOMIC DEVELOPMENT PROGRAMS. (a) 13 The district may engage in activities that accomplish the economic 14 15 development purposes of the district. (b) The district may establish and provide for the 16 17 administration of one or more programs to promote state or local economic development and to stimulate business and commercial 18 19 activity in the district, including programs to: (1) make loans and grants of public money; and 20 21 (2) provide district personnel and services. 22 (c) The district may create economic development programs and exercise the economic development powers provided to 23 24 municipalities by: (1) Chapter 380, Local Government Code; and 25 26 (2) Subchapter A, Chapter 1509, Government Code. Sec. 4014.0307. PARKING FACILITIES. (a) The district may 27

No. 3056 1 acquire, lease as lessor or lessee, construct, develop, own, 2 operate, and maintain parking facilities or a system of parking facilities, including lots, garages, parking terminals, or other 3 structures or accommodations for parking motor vehicles off the 4 5 streets and related appurtenances. 6 (b) The district's parking facilities serve the public 7 purposes of the district and are owned, used, and held for a public 8 purpose even if leased or operated by a private entity for a term of 9 years. 10 (c) The district's parking facilities are parts of and necessary components of a street and are considered to be a street 11 12 or road improvement. 13 (d) The development and operation of the district's parking 14 facilities may be considered an economic development program. 15 Sec. 4014.0308. DISBURSEMENTS AND TRANSFERS OF MONEY. The board by resolution shall establish the number of directors' 16 signatures and the procedure required for a disbursement or 17 transfer of district money. 18 19 Sec. 4014.0309. ADDING OR EXCLUDING LAND. Except as provided by Section 4014.0310, the district may add or exclude land 20 in the manner provided by Subchapter J, Chapter 49, Water Code, or 21 22 by Subchapter H, Chapter 54, Water Code. Sec. 4014.0310. DIVISION OF DISTRICT. (a) The district may 23 24 be divided into two or more new districts only if the district has no outstanding bonded debt. 25 26 (b) This chapter applies to any new district created by the

27 division of the district, and a new district has all the powers and

2	(c) Any new district created by the division of the district
3	may not, at the time the new district is created, contain any land
4	outside the area described by Section 2 of the Act enacting this

23	(g) A political subdivision's consent to the creation of the
24	district and to the inclusion of land in the district granted under
25	Section 4014.0505 acts as the political subdivision's consent to
26	the creation of any new district created by the division of the
27	district and to the inclusion of land in the new district.

1 (h) Any new district created by the division of the district 2 must hold an election as required by this chapter to obtain voter 3 approval before the district may impose a maintenance tax. 4 Sec. 4014.0311. CERTAIN RESIDENTIAL PROPERTY NOT EXEMPT. 5 Section 375.161, Local Government Code, does not apply to the 6 district. 7 Sec. 4014.0312. EMINENT DOMAIN. The district may exercise 8 the power of eminent domain in the manner provided by Section 49.222, Water Code. 9 10 SUBCHAPTER D. ASSESSMENTS Sec. 4014.0401. PETITION REQUIRED FOR FINANCING SERVICES 11 12 AND IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a service or improvement project with assessments under this chapter 13 unless a written petition requesting that service or improvement 14 has been filed with the board. 15 (b) A petition filed under Subsection (a) must be signed by 16 17 the owners of a majority of the assessed value of real property in the district subject to assessment according to the most recent 18 19 certified tax appraisal roll for the county. Sec. 4014.0402. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a) 20 The board by resolution may impose and collect an assessment for any 21 22 purpose authorized by this chapter in all or any part of the 23 district. 24 (b) An assessment, a reassessment, or an assessment 25 resulting from an addition to or correction of the assessment roll 26 by the district, penalties and interest on an assessment or

16 (d) Sections 375.261, 375.262, and 375.264, Local 17 Government Code, do not apply to the district.

5 (b) The governor, one of the required recipients, has 6 submitted the notice and Act to the Texas Commission on 7 Environmental Quality.

8 (c) The Texas Commission on Environmental Quality has filed 9 its recommendations relating to this Act with the governor, 10 lieutenant governor, and speaker of the house of representatives 11 within the required time.

12 (d) All requirements of the constitution and laws of this 13 state and the rules and procedures of the legislature with respect 14 to the notice, introduction, and passage of this Act have been 15 fulfilled and accomplished.

16 SECTION 4. (a) Section 4014.0312, Special District Local 17 Laws Code, as added by Section 1 of this Act, takes effect only if 18 this Act receives a two-thirds vote of all the members elected to 19 each house.

(b) If this Act does not receive a two-thirds vote of all the members elected to each house, Subchapter C, Chapter 4014, Special District Local Laws Code, as added by Section 1 of this Act, is amended by adding Section 4014.0312 to read as follows:

24Sec. 4014.0312. NO EMINENT DOMAIN POWER. The district may25not exercise the power of eminent domain.

26 SECTION 5. This Act takes effect immediately if it receives 27 a vote of two-thirds of all the members elected to each house, as

provided by Section 39, Article III, Texas Constitution. If this
 Act does not receive the vote necessary for immediate effect, this
 Act takes effect September 1, 2025.
