PRESIDING OFFICERS. (a) The position of presiding officer rotates among the governor, lieutenant governor, 14 and speaker of the house of representatives. - 24 Lieutenant Colonel William B. Travis dated February 24, 1836, and

- 27 with jurisdiction over the victory or death letter, shall designate

- 1 an appropriate place in the Alamo complex for the secure display of

- 3 Sec. 443A.104. JURISDICTION OVER CERTAIN ARTIFACTS. Except

- 5 jurisdiction over an artifact or item of historical interest
- 6 associated with the Alamo.
- 7 Sec. 443A.105. AGREEMENT FOR SECURITY OPERATIONS. The
- 8 commission shall enter into an agreement with the Department of
- 9 Public Safety for the department to provide security operations for
- 10 the Alamo complex.
- Sec. 443A.106. ANNUAL BUDGET AND WORK PLAN. (a) The
- 12 commission shall prepare an annual budget and work plan for the
- 13 Alamo complex and the buildings in the complex, their contents, and
- 14 their grounds. The plan must address preservation, usual
- 15 maintenance, and any necessary construction for the complex.
- 16 (b) The commission may satisfy the requirements of this
- 17 section by overseeing the preparation of an annual budget and work
- 18 plan described by Subsection (a) by a qualifying nonprofit
- 19 organization with which the commission contracts under Section
- 20 443A.101(d).
- 21 SECTION 10. Chapter 443A, Government Code, as added by this
- 22 Act, is amended by adding Subchapter D, and a heading is added to
- 23 that subchapter to read as follows:
- SUBCHAPTER D. ALAMO COMPLEX FUND; AUDIT
- 25 SECTION 11. Section 31.454, Natural Resources Code, is
- 26 transferred to Subchapter D, Chapter 443A, Government Code, as

- 13 (c) The speaker of the house of representatives shall serve
- 14 as the third presiding officer of the Alamo Commission as provided
- 15 by Section 443A.053, Government Code, as added by this Act, for a
- 16 term beginning on February 1, 2031, and ending on January 31, 2033.
- 17 (d) On the effective date of this Act or as soon as
- 18 practicable after that date, the lieutenant governor and the
