- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subtitle D, Title 4, Government Code, is amended
- 7 by adding Chapter 443A, and a heading is added to that chapter to
- 8 read as follows:

#### 9 CHAPTER 443A. ALAMO COMMISSION

- 10 SECTION 2. Chapter 443A, Government Code, as added by this
- 11 Act, is amended by adding Subchapter A, and a heading is added to
- 12 that subchapter to read as follows:

## 13 <u>SUBCHAPTER A. GENERAL PROVISIONS</u>

- 14 SECTION 3. Section 31.450, Natural Resources Code, is
- 15 transferred to Subchapter A, Chapter 443A, Government Code, as
- 16 added by this Act, redesignated as Section 443A.002, Government
- 17 Code, and amended to read as follows:
- 18 Sec. <u>443A.002</u> [<del>31.450</del>]. FINDINGS; MEMORANDUM OF
- 19 UNDERSTANDING. (a) The legislature finds that:
- 20 (1) the Alamo has played an important role in the
- 21 history of this state and continues to be a symbol of liberty and
- 22 freedom for this state;
- 23 (2) this state wants to honor the individuals whose
- 24 lives were lost at the Alamo;

- 1 (3) the entire history of the Alamo, from the time the
- 2 Alamo was established as a mission until the present, should be
- 3 recognized; and
- 4 (4) the Alamo is a world-class destination that
- 5 provides a place of remembrance and education.
- 6 (b) The commission [<del>land office</del>] shall enter into a
- 7 memorandum of understanding with the City of San Antonio to
- 8 coordinate the planning and development of improvements to the
- 9 Alamo complex and the area immediately surrounding the complex.
- 10 SECTION 4. Subchapter A, Chapter 443A, Government Code, as
- 11 added by this Act, is amended by adding Sections 443A.001,
- 12 443A.003, and 443A.004 to read as follows:
- Sec. 443A.001. DEFINITION. In this chapter, "commission"
- 14 means the Alamo Commission.
- 15 Sec. 443A.003. ADMINISTRATIVE ATTACHMENT; PROHIBITED USE
- 16 OF CERTAIN FUNDS. (a) The commission is administratively attached
- 17 to the State Preservation Board, and the State Preservation Board
- 18 shall provide administrative support to the commission.
- (b) The commission may not use money in the Texas state
- 20 buildings preservation endowment fund created as provided by
- 21 <u>Section 443.0103 for purposes of this chapter.</u>
- Sec. 443A.004. SUNSET REVIEW. (a) The Alamo Commission is
- 23 <u>subject to Chapter 325 (Texas Sunset Act)</u>. The commission shall be
- 24 reviewed during the period in which the State Preservation Board is
- 25 reviewed under Section 443.002.
- 26 (b) Notwithstanding Subsection (a), the commission may not
- 27 be reviewed during the period the State Preservation Board is

- 1 reviewed before the board is scheduled to be abolished on September
- 2 1, 2029, under Section 443.002. This subsection expires September
- 3 1, 2031.
- 4 SECTION 5. Chapter 443A, Government Code, as added by this
- 5 Act, is amended by adding Subchapter B to read as follows:
- 6 <u>SUBCHAPTER B. ALAMO COMMISSION</u>
- 7 Sec. 443A.051. ALAMO COMMISSION. The Alamo Commission is
- 8 established for the preservation, maintenance, restoration, and
- 9 protection of the Alamo complex and its contents.
- Sec. 443A.052. COMPOSITION OF COMMISSION. (a) The
- 11 commission is composed of five members, as follows:
- 12 (1) the governor;
- 13 (2) the lieutenant governor;
- 14 (3) the speaker of the house of representatives;
- 15 (4) a member of the senate, appointed by the
- 16 <u>lieutenant governor; and</u>
- 17 (5) a member of the house of representatives,
- 18 appointed by the speaker of the house of representatives.
- 19 (b) A board member appointed by the lieutenant governor or
- 20 speaker of the house of representatives serves for a two-year term
- 21 expiring on January 31 of each odd-numbered year.
- 22 <u>Sec. 443A.053. PRESIDING OFFICERS. (a) The position of</u>
- 23 presiding officer rotates among the governor, lieutenant governor,
- 24 and speaker of the house of representatives. A term as presiding
- 25 officer is two years and expires on January 31 of each odd-numbered
- 26 year.
- 27 (b) The commission members who are eliqible to serve but are

- 1 not serving as the presiding officer under Subsection (a) shall
- 2 serve as joint assistant presiding officers for two-year terms
- 3 expiring on January 31 of each odd-numbered year.
- 4 Sec. 443A.054. MEETINGS. The commission shall meet twice
- 5 each year and at the call of the presiding officer or joint
- 6 assistant presiding officers.
- 7 <u>Sec. 443A.055. EXECUTIVE DIRECTOR; COMMISSION PERSONNEL.</u>
- 8 (a) The commission may:
- 9 (1) employ an executive director and other personnel
- 10 necessary for the performance of commission functions; and
- 11 (2) contract for professional services of qualified
- 12 consultants.
- 13 (b) An executive director employed by the commission shall
- 14 perform the duties required by this chapter and any duty delegated
- 15 by the commission.
- 16 <u>(c) The commission may not employ an applicant for the</u>
- 17 position of executive director unless two-thirds of the presiding
- 18 and joint assistant presiding officers vote in favor of employing
- 19 the applicant for the position.
- Sec. 443A.056. EMPLOYMENT OF LOBBYIST. The commission and
- 21 an organization described by Section 443A.101(d) or 443A.102 may
- 22 <u>not use public money to employ, as a regular full-time or part-time</u>
- 23 or contract employee, a person who is required by Chapter 305 to
- 24 register as a lobbyist.
- 25 SECTION 6. Chapter 443A, Government Code, as added by this
- 26 Act, is amended by adding Subchapter C, and a heading is added to
- 27 that subchapter to read as follows:

# SUBCHAPTER C. POWERS AND DUTIES

- 2 SECTION 7. Sections 31.451 and 31.453, Natural Resources
- 3 Code, are transferred to Subchapter C, Chapter 443A, Government
- 4 Code, as added by this Act, redesignated as Sections 443A.101 and
- 5 443A.102, Government Code, respectively, and amended to read as
- 6 follows:

- 7 Sec. 443A.101 [31.451]. PRESERVATION AND MAINTENANCE OF
- 8 ALAMO. (a) The Alamo complex is under the jurisdiction of the
- 9 commission [<del>land office</del>]. The commission [<del>land office</del>] is
- 10 responsible for the preservation, maintenance, and restoration of
- 11 the Alamo complex and its contents and the protection of the
- 12 historical and architectural integrity of the exterior, interior,
- 13 and grounds of the Alamo complex.
- 14 (b) Any power or duty related to the Alamo complex formerly
- 15 vested in any other state agency or entity is vested solely in the
- 16 <u>commission</u> [<del>land office</del>].
- 17 (c) Notwithstanding any other law, the commission [land
- 18 office] is not required to comply with state purchasing law in
- 19 carrying out its duties under this subchapter.
- 20 (d) The <u>commission</u> [<del>land office</del>] may participate in the
- 21 establishment of and partner with a qualifying nonprofit
- 22 organization the purposes of which include raising funds for or
- 23 providing services or other benefits for the preservation and
- 24 maintenance of the Alamo complex. The commission [land office] may
- 25 contract with the organization for the performance of any activity.
- Sec. 443A.102 [31.453]. AGREEMENT WITH DAUGHTERS OF THE
- 27 REPUBLIC OF TEXAS. (a) The commission may [land office shall]

- 6 corporation in this state in accordance with Section 2.008,
- 7 Business Organizations Code, and is exempt from income taxation
- 8 under Section 501(c)(3), Internal Revenue Code of 1986.
- 9 (c)  $\left[\frac{d}{d}\right]$  All property received by the Daughters of the
- 10 Republic of Texas in its capacity as custodian or trustee of the
- 11 Alamo for the benefit of the Alamo is subject to the requirements of
- 12 this subchapter and any [the] agreement entered into under

- SECTION 8. Subchapter C, Chapter 443A, Government Code, as
- 15 added by this Act, is amended by adding Sections 443A.103 and

- 17 Sec. 443A.103. AGREEMENT FOR SECURITY OPERATIONS. The
- 18 commission shall enter into an agreement with the Department of
- 19 Public Safety for the department to provide security operations for
- 20 the Alamo complex.
- Sec. 443A.104. ANNUAL BUDGET AND WORK PLAN. The commission
- 22 shall prepare an annual budget and work plan for the Alamo complex
- 23 and the buildings in the complex, their contents, and their
- 24 grounds. The plan must address preservation, usual maintenance,
- 25 and any necessary construction for the complex.
- SECTION 9. Chapter 443A, Government Code, as added by this
- 27 Act, is amended by adding Subchapter D, and a heading is added to

- 1 that subchapter to read as follows:
- 2 SUBCHAPTER D. ALAMO COMPLEX FUND; AUDIT
- 3 SECTION 10. Section 31.454, Natural Resources Code, is
- 4 transferred to Subchapter D, Chapter 443A, Government Code, as
- 5 added by this Act, redesignated as Section 443A.151, Government
- 6 Code, and amended to read as follows:
- 7 Sec. 443A.151 [31.454]. [THE] ALAMO COMPLEX ACCOUNT. (a)
- 8 The Alamo complex account is a separate account in the general
- 9 revenue fund.
- 10 (b) The account consists of:
- 11 (1) transfers made to the account;
- 12 (2) fees and other revenue from operation of the Alamo
- 13 complex;
- 14 (3) grants, donations, and bequests from any source
- 15 designated for the benefit of the Alamo complex; and
- 16 (4) income earned on investments of money in the
- 17 account.
- 18 (c) The commission [land office] may accept a gift, grant,
- 19 or bequest of money, securities, services, or property to carry out
- 20 any purpose related to the preservation and maintenance of the
- 21 Alamo complex, including funds raised or services provided by a
- 22 volunteer or volunteer group to promote the commission's duties
- 23 <u>under this chapter</u> [work of the land office]. All proceeds under
- 24 this subsection shall be deposited to the credit of the account.
- 25 (d) Appropriations to the commission [land office] for the
- 26 preservation, operation, or maintenance of the Alamo complex shall
- 27 be deposited to the credit of the account.

- 1 (e) The <u>commission</u> [<del>land office</del>] may use money in the
- 2 account only to administer this <a href="mailto:chapter">chapter</a> [subchapter], including to
- 3 support the preservation, repair, renovation, improvement,
- 4 expansion, equipping, operation, or maintenance of the Alamo
- 5 complex or to acquire a historical item appropriate to the Alamo
- 6 complex.
- 7 (f) Any money in the account not used in a fiscal year
- 8 remains in the account. The account is exempt from the application
- 9 of Section 403.095[<del>, Government Code</del>].
- SECTION 11. Subchapter D, Chapter 443A, Government Code, as
- 11 added by this Act, is amended by adding Section 443A.152 to read as
- 12 follows:
- Sec. 443A.152. ANNUAL AUDIT. The commission shall have an
- 14 annual audit conducted by an independent auditor of any
- 15 expenditures of public money for purposes of this chapter by a
- 16 nonprofit organization with which the commission contracts under
- 17 Section 443A.101(d).
- 18 SECTION 12. The following provisions are repealed:
- 19 (1) Section 31.0515, Natural Resources Code;
- 20 (2) the heading to Subchapter I, Chapter 31, Natural
- 21 Resources Code;
- 22 (3) Section 31.452, Natural Resources Code;
- 23 (4) Section 31.455, Natural Resources Code; and
- 24 (5) Section 1, Chapter 984 (S.B. 2612), Acts of the
- 25 88th Legislature, Regular Session, 2023, which amended former

- 27 SECTION 13. (a) As soon as practicable after the effective

- 1 date of this Act, the state auditor shall conduct an audit of any
- 2 expenditures of public money by the General Land Office with
- 3 respect to the Alamo complex and any expenditures of public money by
- 4 a nonprofit organization with which the General Land Office
- 5 contracted before the effective date of this Act under Section
- 6 31.451(d), Natural Resources Code, to ensure an accurate
- 7 understanding of those expenditures and to aid in the transfer of
- 8 authority relating to the Alamo complex to the Alamo Commission, as
- 9 established by this Act.
- 10 (b) Not later than January 1, 2028, the state auditor shall
- 11 prepare and submit to the Alamo Commission, as established by this
- 12 Act, a report on the findings of the audit conducted under
- 13 Subsection (a) of this section.
- 14 SECTION 14. The term of a member serving on the Alamo
- 15 Preservation Advisory Board immediately before the effective date
- 16 of this Act whose position on the board is abolished by the changes
- 17 in law made by this Act expires on the effective date of this Act.
- SECTION 15. (a) In this section, "commission" means the
- 19 Alamo Commission established by Chapter 443A, Government Code, as
- 20 added by this Act.
- 21 (b) On September 1, 2027, or as soon as practicable after
- 22 that date, the General Land Office and the commission shall enter
- 23 into a memorandum of understanding relating to the transfer of
- 24 power and duties from the General Land Office to the commission as
- 25 provided by this Act. The memorandum of understanding must:
- 26 (1) include a comprehensive plan to ensure the orderly
- 27 transition of the preservation, maintenance, and restoration of the

- 2 (2) provide for the completion of the transfer by

- 4 (c) Not later than January 1, 2028, all powers, duties,
- 5 obligations, rights, contracts, bonds, appropriations, records,
- 6 property, and personnel of the General Land Office related to the
- 7 Alamo complex are transferred to the commission as provided for in
- 8 the memorandum of understanding entered into under Subsection (b)
- 9 of this section.
- 10 (d) A rule, policy, procedure, or decision of the General
- 11 Land Office continues in effect as a rule, policy, procedure, or
- 12 decision of the commission, as appropriate, until superseded by an
- 13 act of the commission.
- 14 (e) Notwithstanding the transfer, redesignation, and repeal
- 15 of provisions of Subchapter I, Chapter 31, Natural Resources Code,
- 16 and Section 1, Chapter 984 (S.B. 2612), Acts of the 88th
- 17 Legislature, Regular Session, 2023, by this Act, the General Land
- 18 Office shall continue to perform duties and exercise powers under
- 19 those laws as they existed immediately before the effective date of
- 20 this Act until the date provided by the memorandum of understanding
- 21 entered into under Subsection (b) of this section.
- 22 SECTION 16. (a) The governor shall serve as the first
- 23 presiding officer of the Alamo Commission as provided by Section
- 24 443A.053, Government Code, as added by this Act, for a term ending
- 25 on January 31, 2029.
- 26 (b) The lieutenant governor shall serve as the second
- 27 presiding officer of the Alamo Commission as provided by Section

- 1 443A.053, Government Code, as added by this Act, for a term
- 2 beginning on February 1, 2029, and ending on January 31, 2031.
- 3 (c) The speaker of the house of representatives shall serve
- 4 as the third presiding officer of the Alamo Commission as provided
- 5 by Section 443A.053, Government Code, as added by this Act, for a
- 6 term beginning on February 1, 2031, and ending on January 31, 2033.
- 7 (d) On the effective date of this Act or as soon as
- 8 practicable after that date, the lieutenant governor and the
- 9 speaker of the house of representatives shall each appoint a
- 10 person, as required by Section 443A.052, Government Code, as added
- 11 by this Act, to the Alamo Commission to serve a term ending on
- 12 January 31, 2029.
- SECTION 17. It is the intent of the 89th Legislature,
- 14 Regular Session, 2025, that the amendments made by this Act be
- 15 harmonized with another Act of the 89th Legislature, Regular
- 16 Session, 2025, relating to nonsubstantive additions to and
- 17 corrections in enacted codes.
- 18 SECTION 18. This Act takes effect September 1, 2027.
