The chair laid out SB 1262 and recognized the author, Senator Nichols, to explain the bill.

Senator Paxton sent up a committee substitute. The chair recognized Senator Nichols to explain the difference between the committee substitute and the senate bill as filed. Senator Paxton moved the adoption of the committee substitute; without objection, it was so ordered.




Senator Parker moved that SB 1459 and SB 2365 be left pending; without objection, it was so ordered.
