The chair moved that the public testimony be closed; without objection, it was so ordered.

Senator Creighton moved that SB 1322 be left pending; without objection, it was so ordered.

The chair laid out SB 1998 and recognized the author, Senator Huffman, to explain the bill.

Senator Bettencourt moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.

Witnesses testifying and registering on the bill are shown on the attached list.


The chair moved that the public testimony be closed; without objection, it was so ordered.
