The motion carried with a record vote of 5 ayes, 4 nays, 0 present not voting, and 0 absent.

Senator Perry moved that SB 296 be reported favorably to the Senate with the recommendation that it do pass and be printed. The motion carried with a record vote of 9 ayes, 0 nays, 0 present not voting, and 0 absent. Senator Perry moved that the bill be recommended for placement on the Local & Uncontested Calendar; without objection, it was so ordered.
