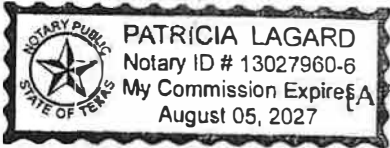

This is to give notice of intent to introduce in the 89th Legislature, Regular Session, a bill to be entitled an Act relating to the creation of the Craver Ranch Municipal Management District, a special district operating under Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and Chapters 372 and 375, Texas Local Government Code, providing authority for the District to impose assessments, fees, and taxes, and providing authority to issue bonds, affecting lands in Denton County, Texas, being generally located in the northern portion of the corporate limits and extraterritorial jurisdiction of the City of Denton, Texas, east of FM 2164, west and south of FM 2153, and north of Gribble Springs Road and Shepard Road.
