According to a publication by the NIH, ivermectin can be considered as a "wonder drug" alongside penicillin and aspirin. This title is "based on its versatility, safety, and the beneficial impact that it has had, and continues to have, worldwide--especially on hundreds of millions of the world's poorest people." It deserves to be readily available to the public.

In my position as president of Texas Eagle Forum, I have heard from many of our members on the issue of not being able to obtain Ivermectin when needed. My doctor will not prescribe it because her giant hospital network tells her not to. I have personally experienced covid twice. The first time I immediately began to search for products known tp have been helpful to others. I had Hydroxychloroquine and wanted to obtain ivermectin as well. I finally found a doctor who would prescribe it for me, but it had to go through a compounding pharmacy about 30 miles from my home and would not be available until after the weekend. My husband had covid as well and without this medicine we both ended up in hospitals. My initial stay was 11 days. I was refused both ivermectin and budesonide by the hospital doctors. Instead, without my permission they started me on Remdesivir - a very expensive drug. This unproven drug impacted my kidneys, heart and lungs negatively as all my bloodwork and physical symptom got worse over time. I knew my covid was over but my formerly healthy body was not functioning well anymore. I was released but had to return after a week when my oxygen levels dropped to the 60 percent range every time I stood up. They wanted to call it long covid but it was caused by a terrible medication I never wanted to take. It took almost a year for my bloodwork to become normal again. Fast forward 2 years, 11 1/2 months when I got covid a second time. I took ivermectin and used budesonide for my lungs. I recovered in 3-4 days with rest and those two meds. The early symptoms were the same but the treatment was what I wanted to use the first time. My first case was terribly expensive financially and physically. My second case was exponentially different.

Getting medicines that are known to be safe should be easy and accessible. I would have been saved many months of hardship if I could have had a friend run to a local pharmacy and grab it for me.

Thank you for hearing HB 3219 and I ask you to give Texans more medical freedom by passing it out of committee with a recommendation that it move quickly to the House floor for passage.

Ivermectin is not a cure all; though there is some promising evidence of antiviral/antibacterial activity, it is NOT conclusive nor better than currently available therapies. Unregulated prescribing of ivermectin will lead to resistance which could decimate the veterinarian/agriculture industry where ivermectin is used widely for parasitic infections. This would be disastrous.

Whoever wrote this bill should have NO place on the Public Health committee. This bill is dangerous for Texans and irresponsible.

Prescription requirements strain healthcare providers, especially during pandemics or in high-prevalence areas for parasitic diseases. OTC ivermectin would free up resources for critical cases, reducing the need for routine doctor visits for a low-risk drug.

5. Precedent with Other OTC Drugs

Medications like ibuprofen, with risks if misused, are OTC. Ivermectin's safety profile supports similar access, with clear dosing instructions. Public education could prevent misuse, as seen with other OTC drugs.

6. Reduces Black Market Risks

During COVID-19, demand for ivermectin spurred black market sales and dangerous use of veterinary versions. OTC human-grade ivermectin would provide a regulated alternative, ensuring safer use with proper guidelines.

7. Supports Patient Autonomy

OTC access respects individual freedom to use safe, well-studied drugs. Informed users could weigh risks and benefits for parasitic infections or off-label purposes, especially where trust in medical systems is low.

8. Addressing Misuse Concerns

Critics fear misuse, but OTC status could include strict labeling and public education, as with other drugs. Mass distribution programs show people can use ivermectin responsibly with guidance.

I have treated thousands of patients with ivermectin and can attest to its safety. I rarely have patients report side effects, and if they do, they are seen with high doses and are transient. I see far more issues with antibiotics I prescribe than I do with ivermectin. I have never had a patient need to seek medical care due to a side effect. Before I started prescribing ivermectin, I researched the safety data, going to the FDA's website to find the original study Merck submitted to get the drug approved. That study contains toxicity data, in particular the LD50 which is a benchmark number used to measure a drug's toxicity. It means "lethal dose 50" and indicates the amount of drug that would kill 50% of lab animals. The LD50 varies depending on the lab animal but on average is about 25mg/kg. The doses used to treat COVID are 0.2mg/kg - 0.6mg/kg. Also there is only one published study showing a possible fatality from ivermectin overdose whereas thousands have been published about Tylenol. Ivermectin has been taken by over 4 billion people around the world but continues to be difficult to access in Texas. The FDA branded it as horse medicine, and since then, physicians won't prescribe it, pharmacists won't dispense it, and insurance companies won't pay for it. Three states, Tennessee, Idaho and Arkansas, have passed legislation like HB3219 to make ivermectin over the counter, and 14 states have bills under consideration. Texas led the country in unconstitutional vaccine mandates when Houston Methodist became the first in the country to mandate the COVID shots on April 1, 2021. Vaccine mandates violate the fundamental human right of bodily autonomy, and Methodist's actions are a stain on our state's reputation. HB3219 is one step towards correcting that mistake and shows support for individual patient rights and medical freedom.

We got the word out to my parent's Sunday School group. Interestingly, the church had a worship team in Harlingen attending a small group event. They immediately were escorted to Mexico, where they met with a Mexican doctor. The doctor provided the worship team with a large bag of pharmaceuticals, mainly multiple boxes of Ivermectin, including instructions for administration in English. The doctor sold the team 20 of these treatment bags. The team drove all night back to north East Texas, delivering them to my parents at 6am. My mother is a nurse and immediately began treatment for both herself and my dad. Within 24 hours of taking Ivermectin, my father's SpO2 increased to 90% and he could get out of bed and walk across his bedroom. My parents eventually made a recovery, although my mother lost her taste and smell for the next 12 months, which was immediately resolved after a CRNA administered a Stellate Ganglion block.

I've told everyone I can that the MEXICAN HEALTHCARE SYSTEM saved my parent's lives. All because they recognized the benefits of Ivermectin and knew it was so safe, they were willing to give it to lay individuals. Introduction

Ivermectin, a broad-spectrum antiparasitic drug, has been a cornerstone of global health since its discovery in the 1970s. Approved for human use by the U.S. Food and Drug Administration (FDA) in 1987, it has transformed the treatment of parasitic diseases like onchocerciasis (river blindness) and strongyloidiasis, earning its discoverers, Satoshi Omura and William Campbell, the 2015 Nobel Prize in Physiology or Medicine. Beyond its established role, ivermectin has garnered significant attention, particularly during the COVID-19 pandemic, for its potential antiviral and anti-inflammatory properties. Thousands of anecdotal reports on platforms like X have fueled public interest, with users claiming benefits in treating or preventing COVID-19. This draft evaluates the scientific evidence supporting ivermectin's use in humans, focusing on its established indications, emerging research, and the context of anecdotal claims, while critically addressing controversies and limitations.

Established Uses of Ivermectin in Humans

Ivermectin is FDA-approved for treating parasitic infections, including intestinal strongyloidiasis, onchocerciasis, and ectoparasitic conditions like scabies and head lice. It is administered orally for systemic infections (e.g., $150-200~\mu g/kg$ for strongyloidiasis) or topically for conditions like rosacea and head lice. Its safety profile is well-documented, with over 3.7 billion doses distributed globally through programs like the Mectizan Donation Program, which has significantly reduced the burden of river blindness in endemic regions. Common side effects, such as headache, dizziness, and fatigue, are generally mild, with severe adverse events rare at approved doses.

Ivermectin's mechanism of action in parasitic infections involves targeting glutamate-gated chloride channels in invertebrates, causing paralysis and death of parasites without significant toxicity in mammals due to its inability to cross the blood-brain barrier at therapeutic doses. This selectivity underpins its safety, making it a mainstay on the World Health Organization's (WHO) Essential Medicines List. The drug's long history of safe use in humans provides a foundation for exploring its potential in other conditions, supported by its low cost and wide availability.

Emerging Evidence for Antiviral and Anti-Inflammatory Effects

Recent research has explored ivermectin's broader pharmacological properties, including antiviral, anti-inflammatory, and even anticancer effects. In vitro studies have demonstrated that ivermectin inhibits replication of a range of viruses, including RNA viruses like Zika, dengue, yellow fever, and severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), as well as DNA viruses like equine herpesvirus. For SARS-CoV-2, a 2020 study showed that ivermectin reduced viral RNA by approximately 5,000-fold in Vero-hSLAM cells within 48 hours, suggesting potential as an anti
