My name is Mary Harris. I live in Denton, have been a teacher or teacher educator at public universities in four states, and am now retired from the University of North Texas. In 1967, I completed my student teaching in Baltimore City Public Schools at the middle school where the son of Madalyn Hurray O'Hair was a student a few years earlier when she named him as plaintiff in a lawsuit that eventually contributed to the Supreme Court's 1963 decision against Bible reading in public schools. The previous year, the Supreme Court had banned organized prayer in public schools.

Having attended public school in Pennsylvania before these rulings, I experienced daily Bible reading and prayer in public school. In second grade, Mrs. Miller had us daily recite Psalm 1 before reciting The Lord's Prayer. I can still recite Psalm 1 but remember no other aspect of what 12 years of public-school prayer and Bible reading taught me. I am a strong Christian, but this is entirely due to my parents, who led family prayer every day and took us to church and Sunday School every week and Bible school in the summer.

I urge you to vote "no" on SB 11 for consideration by the Texas House of Representatives. The authors of this bill are obviously aware of current U.S. law on public school prayer and Bible reading and have developed a work-around so complicated as to consume much time of school employees in badgering parents to abrogate their right to raise children in the religion of their choice. My students in Texas have been Jewish, Muslim, and Hindu, as well as Christian, or of no faith. SB 11 may coerce parents to subject children to common prayer and Bible reading merely to avoid being different. It would require public schools and districts to spend much time organizing an activity not part of the positions for which they are trained or certified. I am sure you realize that any public-school student or employee may pray silently at any time.

Thank you for the opportunity to submit testimony in strong opposition to Senate Bill 11, which would allow school prayer and Bible reading sessions in public schools during instructional time.

While religious freedom is a foundational American value, SB 11 threatens that freedom by blurring the line between church and state in a way that endangers the rights of all students. Public schools are not places of worship—they are places of learning, supported by taxpayer dollars and attended by students of every faith and belief system.

Here are key reasons why I urge you to reject SB 11:

- It violates constitutional principles. The U.S. Supreme Court has consistently ruled that government-sponsored religious activity in public schools—particularly during the school day—is a violation of the Establishment Clause of the First Amendment. Students and staff are already free to pray or read religious texts privately and voluntarily; this bill moves toward state-endorsed religion, which is unconstitutional.
- It undermines inclusivity. Students come from diverse religious and nonreligious backgrounds. Endorsing specific religious practices in schools can marginalize or alienate students who don't share those beliefs. No student should feel pressured or excluded in a public school setting based on their faith—or lack thereof.
- It invites legal and financial risk. Enacting policies that contradict longstanding legal precedent could expose school districts to lawsuits, draining resources that should be spent on instruction, materials, and teacher support—not litigation.
- It distracts from educational goals. Public schools face pressing challenges: underfunding, teacher shortages, and learning loss. Instead of addressing these urgent needs, SB 11 risks turning classrooms into battlegrounds over religion.

Religious freedom means freedom of religion, not the imposition of religion. Protecting that freedom requires that public institutions, especially schools, remain neutral in matters of faith. SB 11 violates that neutrality and risks harming the very students it claims to support.

I respectfully urge the committee to vote NO on SB 11 and protect the religious liberty of all Texas students and families.

Temple Emanu-El in Dallas is a Reform Jewish Congregation with over 2550 member families. We oppose SB-11, a bill that would authorize school districts to permit organized time during the school day for prayer and Bible readings. We believe this is an unconstitutional violation of the First Amendment and the fundamental rights of parents to raise their children in the religion of their choice without their children feeling coerced into prayer during the school day. This is especially true for younger children who may not yet be established in their own religious upbringing as well as for all children who are subject to peer pressure to belong and feel welcome in their classes. While SB 11 is clear that parents must opt their children into the "voluntary" prayer time, it is still coercive for those children whose parents have not given permission when many of their classmates leave to attend prayer readings at school. It is also unfair to parents that only opt their children into prayer activities due to their children's feelings of being left out of school activity.

This is an unnecessary intrusion of religion into public schools. Students have the "absolute right to individually, voluntarily, and silently pray or meditate in school in a manner that does not disrupt the instructional or other activities of the school" (Education Code Section 25.901). They can pray before tests, before lunch, during breaks, before athletic or other events. Adding organized prayer in public schools even if "voluntary" we believe violates the First Amendment.

We note that if this Bill becomes law Texas will spend many tax dollars to defend this scheme to bring organized religion into public schools. This is not a good expenditure of tax dollars.

Thank you for the opportunity to present our opposition to this Bill. We urge you to reject this bill.

Good afternoon. I'm Marti Bier, Chief Program Officer at the Texas Freedom Network, an organization of parents, young people, faith leaders and other Texans who support public education and religious freedom. I'm here to testify in opposition to SB11.

It is unnecessary to affirm the right of students to pray or read religious texts. Students and school employees already have and exercise their constitutionally protected religious freedom across the state every day, including myself when I was a public school student. In an attempt to solve a problem that does not exist, this bill creates many problems of its own.

Special periods set aside for prayer and Bible reading in public schools are inherently coercive, no matter how voluntary this bill pretends they would be. In fact, the bill actually modifies the Education Code to allow a teacher – an authority figure – to encourage a student to pray. That's the job of parents and congregations, not public schools that enroll students who come from many different faith traditions or whose families are not religious at all.

Moreover, keep in mind that the section of the bill that would allow teachers to encourage students to pray also gives teachers the power to encourage students to refrain from prayer. Public schools have no business encouraging or discouraging matters of faith.

In large part because of these concerns, this bill leaves public schools vulnerable to expensive First Amendment lawsuits. That's true whether or not the school district is represented by the state attorney general. It makes no sense to put tax dollars at risk, particularly at a time when public schools are struggling for the funds they need to serve their students.

You can protect religious freedom by ensuring public schools teach students to respect the rights of everyone. That includes respecting the student or teacher who prays with friends at lunch or reads the Bible or the Quran between classes.

Religious freedom is a foundational value in our state and a cornerstone of our democracy. But this bill would undermine the religious freedom of all Texas students, teachers and families.

Defending Voluntary Expression and Separation of State from Religion

SB 11 allows school districts and charter schools to mandate a daily period of prayer and Bible or religious text reading for students and employees, contingent on signed consent forms. While framed as voluntary, the structure of this policy imposes unnecessary government involvement in religious practices and creates a coercive framework under threat of state litigation protections and waivers.

LPTexas Stands for Religious Liberty, Not Religious Regulation

The Libertarian Party of Texas fully supports the right of individuals to practice religion freely, including prayer in school. However, we oppose all efforts by the government to sponsor, require, or formalize religious activity, even when technically voluntary (Platform § I.1.b, Freedom of Religion). True religious liberty must remain free from state involvement, influence, or endorsement.

State-Coordinated Religion Is Inherently Coercive

SB 11 establishes a government-sanctioned religious practice period in public schools and provides legal and financial protections to districts that adopt it. This represents state favoritism toward religion and invites the chilling of dissent or non-participation. Mandating a policy—even with opt-in waivers—creates social and institutional pressure that contradicts the Libertarian principle of voluntaryism (Platform – Statement of Principles).

Local Control and Educational Focus Undermined

LPTexas supports local autonomy and decentralization in education (Platform § II.2.a, General Education), and opposes top-down mandates or politically motivated rituals in public institutions. SB 11 distracts from core educational missions and imposes unnecessary administrative burdens and legal entanglements on school districts.

Conclusion

The Libertarian Party of Texas opposes SB 11 as a state-driven effort to insert coerced religious observance into public education. While affirming every individual's right to pray voluntarily, LPTexas rejects policies that place the government in the role of religious facilitator. We urge lawmakers to reject SB 11 and instead defend both freedom of religion and freedom from state-sponsored religious coercion.

I am a seminarian on the path to Unitarian Universalist ministry with a call to chaplaincy. As a chaplain at a children hospital, I have prayed with and for children and their families during pastoral encounters where they are searching for meaning in their time of crisis and discerning their relationship with the sacred and the God of their understanding. This exploration and relationship must always be free and voluntary to be authentic. Each person's connection with God is sacred. It is not for other humans to interfere with or coerce this connection.

One sponsor of this bill has stated: "There is eternal life and if we don't expose our children and others to that, then when they die, they'll have one birth and two deaths." Thus, these bills promoting a particular version of Christianity in public schools are overtly an attempt to convert people to Christianity. However well-meaning, this is inappropriate anywhere but in a theocracy. Parents are the primary religious and spiritual educators of their children and have the right to teach their children at home. This includes the decision to teach no religion. When schools push sectarian views on children and youth, it undermines the home-based spiritual teachings. It's particularly offensive when the state uses its power to subject children and youth who are members of a minority religion, or whose parents have decided to refrain from raising their children within a particular religion, to conversion efforts. Simply put, this is the theft of tradition and culture from those students.

Consent forms are not sufficient. They serve only to identify the students who are not members of the majority religion to their teachers and peers. This bill removes the word "encourage" from Section 25.901 and as such once targeted by opting out of prayer, teachers and peers would be allowed to "encourage" them to change their minds and join the prayer. Teachers and students may feel very real pain when they think that others will spend eternity in hell and feel compelled to encourage them to change.
