Relating to the governance of public housing authorities established by municipalities.

HB 5370 Cortez
Relating to the requirements for interlocal contracts.

HB 5424 Bonnen
Relating to volunteer firefighter compensation limits.

HB 5466 Kitzman
Relating to the compensation of directors of the Aliana Management District.

HB 5509 Bumgarner
Relating to the suspension or revocation of a hotel's or motel's certificate of occupancy by a municipality for suspected human trafficking.

HB 5660 Muñoz
Relating to the dissolution of the El Milagro Management District.

HB 5673 Zwiener
Relating to the creation of La Cima Municipal Management District No. 1; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes; granting a limited power of eminent domain.
