Relating to the rating of child-care providers participating in the Texas Rising Star Program that install certain safety barriers.

HB 5144 Louderback | et al.
Relating to prohibiting certain deceptive trade practices by businesses assisting veterans with Department of Veterans Affairs claims.

Relating to discontinuing group self-insurance coverage and dissolving the Texas self-insurance group guaranty fund and trust fund under the Texas Workers' Compensation Act.

SB 1244 Schwertner
Relating to unclaimed personal property, including virtual currency.

SB 1343 Johnson | et al.
Relating to the notice requirements of a data broker registration statement and Internet website.

SB 2121 Johnson
Relating to the regulation of certain business entities that act as data brokers.
