21	employer as prescribed by the contract.

No. 762 1 employment agreement, or renewal or renegotiation of an existing 2 contract or employment agreement, that contains a provision for 3 severance pay with an employee or independent contractor must 4 include: 5 (1) a requirement that severance pay that is paid from tax revenue may not exceed the amount of compensation, at the rate 6 at the termination of employment or the contract, the employee or 7 8 independent contractor would have been paid for 20 weeks, excluding paid time off or accrued vacation leave; and 9 10 (2) a prohibition of the provision of severance pay when the employee or independent contractor is terminated for 11 12 misconduct. (d) A political subdivision shall post each severance 13 agreement in a prominent place on the political subdivision's 14 Internet website. 15 (e) This subsection applies to an action brought against a 16 political subdivision by an employee or independent contractor of 17 the political subdivision arising from the termination of the 18 person's employment or contract. A court may not issue a writ of 19 execution or mandamus in connection with a judgment in the action if 20 the judgment does not comply with this section. 21 SECTION 2. Section 180.011, Local Government Code, as added 22 by this Act, applies only to a contract entered into or an action 23 24 filed on or after the effective date of this Act. 25 SECTION 3. This Act takes effect September 1, 2025.
